## VIII. Comments and Announcements

### a. Program Updates

- i. **MALPF-** Extended 5 offers for FY25. One baseline has been completed as the landowner has already had the property surveyed. The next application deadline will be 4/1/2026.
- ii. **IPP-** There are 2 settlements in October, Adams and CFW. For the FY26 IPP cycle, staff received 47 applications.
- iii. **Rural Legacy-** Still receiving interest in this program. We are working on a few projects currently, working their way toward settlement.
- iv. **CREP-** Staff continue to receive a lot of interest in this program. One easement is set to settle at the end of October. We are waiting for the Deed of Easement from DNR.
- v. **Critical Farms-** There are no new updates for critical farms. The next cycle will open sometime in 2027.
- vi. **Next Generation-** There is currently a project going through the works. It was submitted at the end of May. It typically takes 6-9 months to get to the settlement table. We still receive a lot of interest in this program, along with Small Acreage Next Generation.

### B. Other Comments:

- i. **MPRP Proposed Transmission Line Route-** There are no new official updates. The Maryland Public Service Commission filed a proposed schedule to assess a PSEG's application. The proposed procedural schedule recommended to the commission by its staff and the state Power Plant Research Program (PPRP) begins in fall of 2025, includes public hearings in 2026, and continues through March 2027.
