A. Frederick County Executive, Mrs. Jan Gardner:

County Executive Gardner also noted that a budget transfer was recently approved by the County Council to fund additional positions for a boat crew.

C. Fire & Rescue Division Director, Chief Tom Coe

Ball Road Incident

Thanks to everyone in the community, fire service and mutual aid departments for all of their help. NIOSH team conducted investigation and will submit a draft report of their findings in the next 6-8 months. In addition, an External Safety Review Panel has been established to review the incident and make recommendations to limit the possibility of a similar incident from happening again.

Flooding

Personnel responded to over 200 calls for service during the recent flooding.

Budget

Budget adjustment for staffing improvements to the Point of Rocks Fire Station was approved by the County Council on August 10th.

DFRS Events

Promotional and annual awards ceremony originally scheduled for September 2nd has been postponed until late October.

Training

Recruit Classes 30 & 31 remain in session with a total of 45 recruits who are slated to graduate in mid-February.

Current Paramedic class is in their capstone project and slated for National Registry testing in November.

Facilities

PSTF parking lot construction continues. Project expected to be completed by early October.

Construction continues on the Northgate Fire Station. May have some delays due to supply chain issues. Construction to be completed late January or early February.

Facility renovations at the new Logistics warehouse on Tilco Drive continues to progress. Hope to move to the new facility in December of this year.

Will offer support to the Great Frederick Fair.

D. President, FCVFRA, James May:

President May stated that he did not have anything to report for the September meeting.

As President Jones was absent, no report was given.

B. EMS Committee

Chief Coe noted that the ongoing pandemic is still in the community and flu shots for responders will begin in October.


FRAB Representation
