The previously approved impervious area acreage is maintained (and reduced), as noted on sheet C-000. Revised grading based on final racking specifications. The grading reduces the previously approved grading areas and reduces the earthwork estimate, as noted on sheet C-000. Proposed impervious area is reduced from the previously approved plans.
