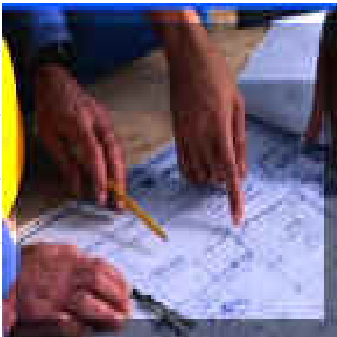
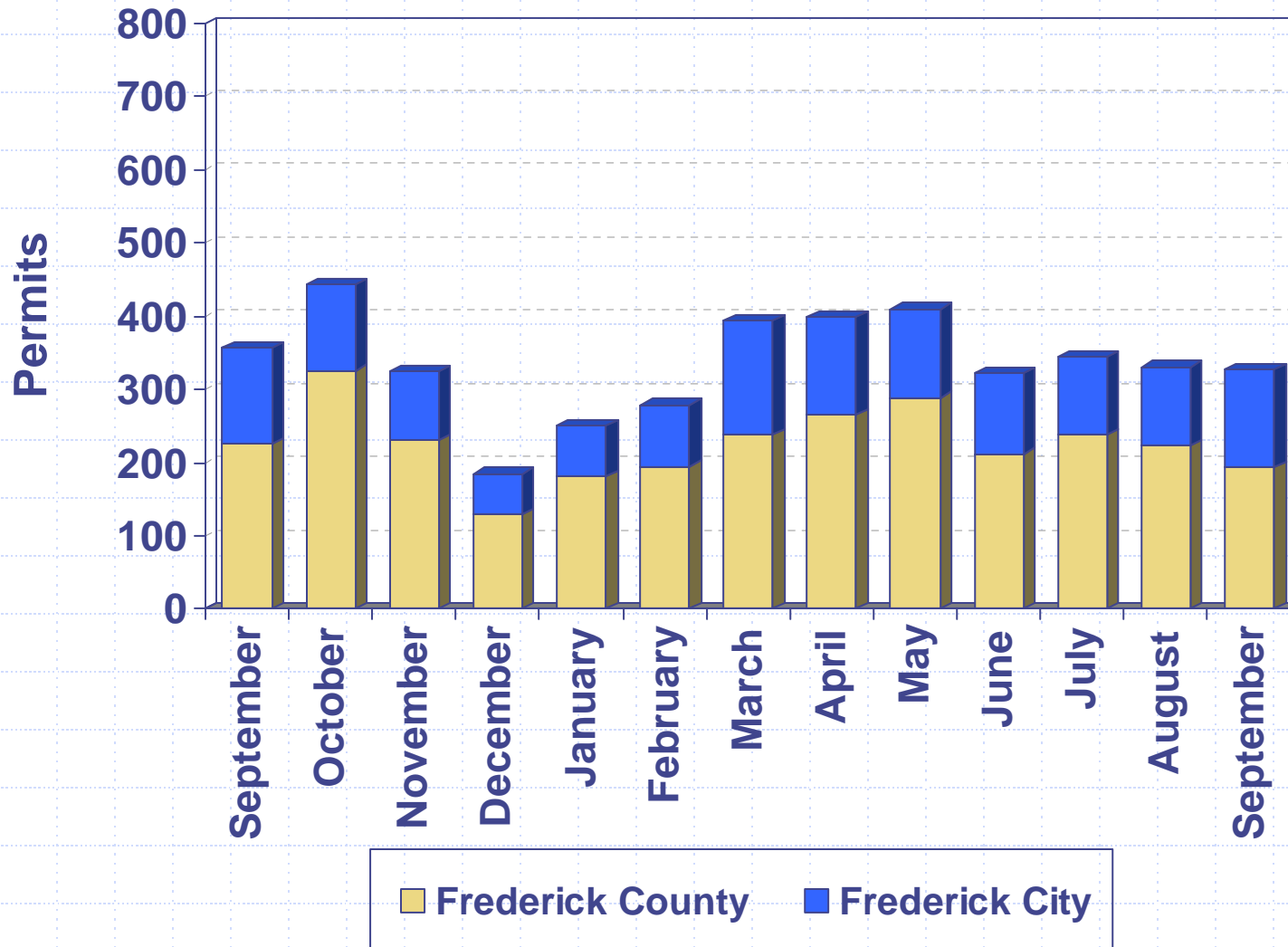

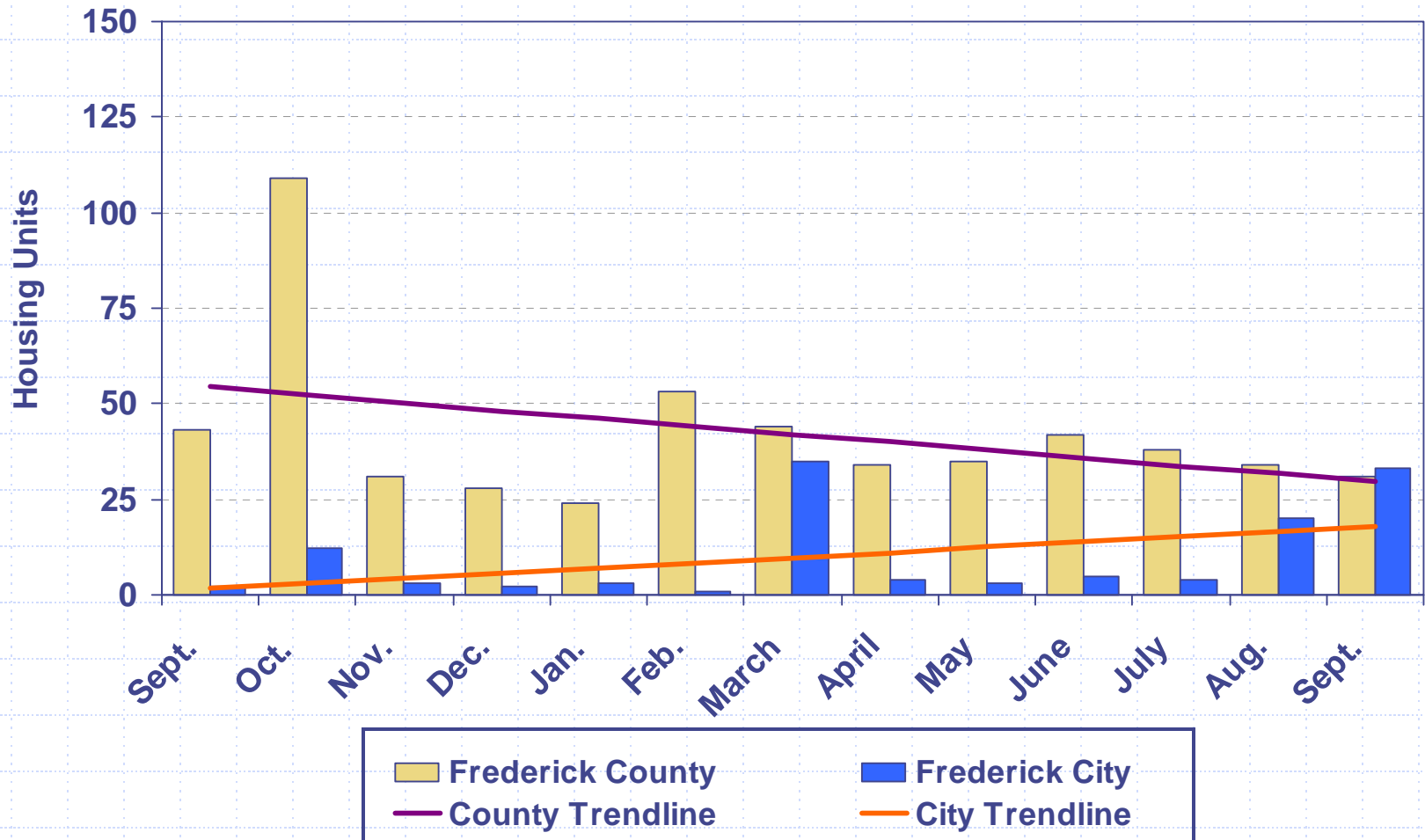


Building Permits Issued 2007 - 2008

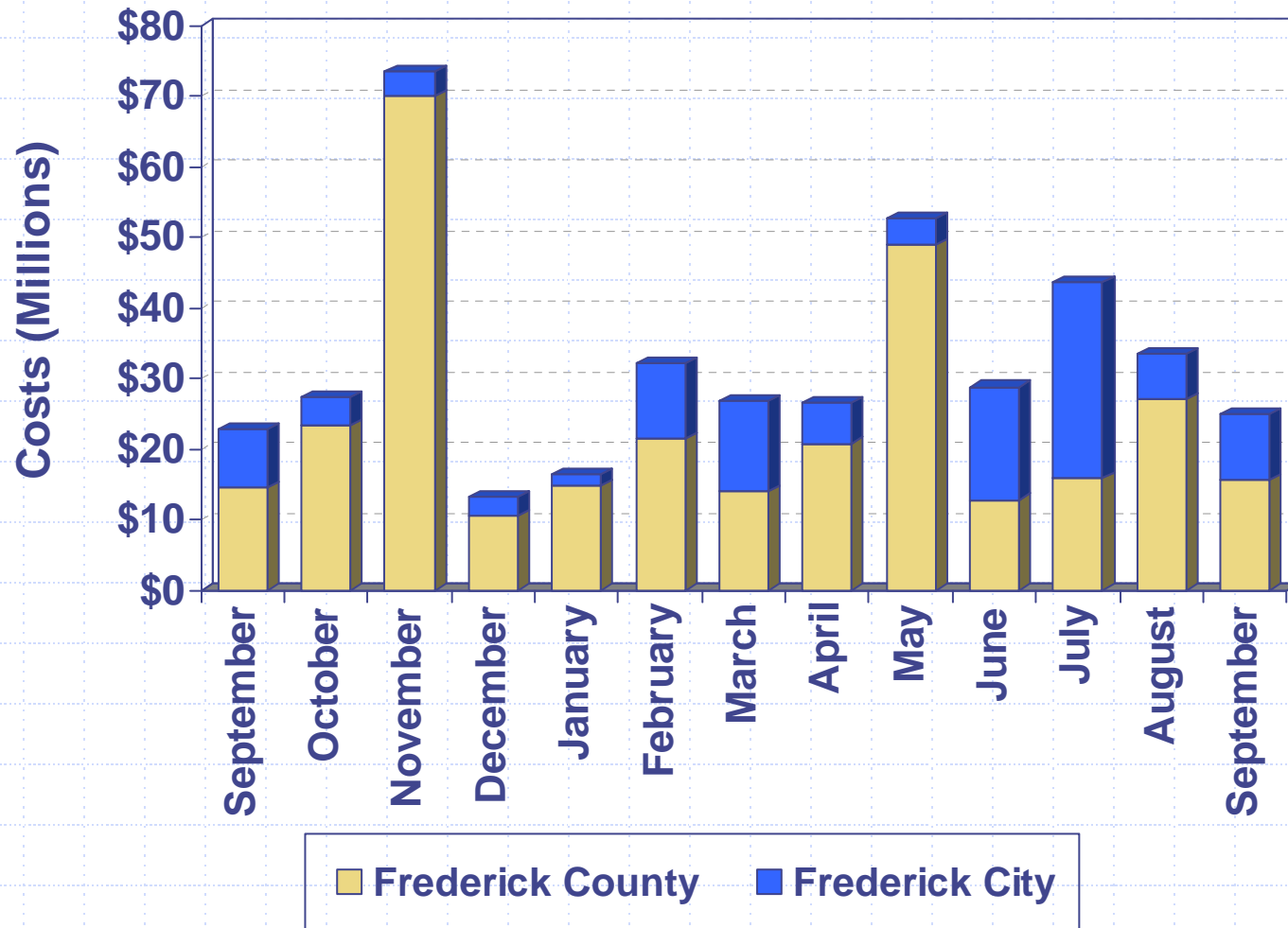

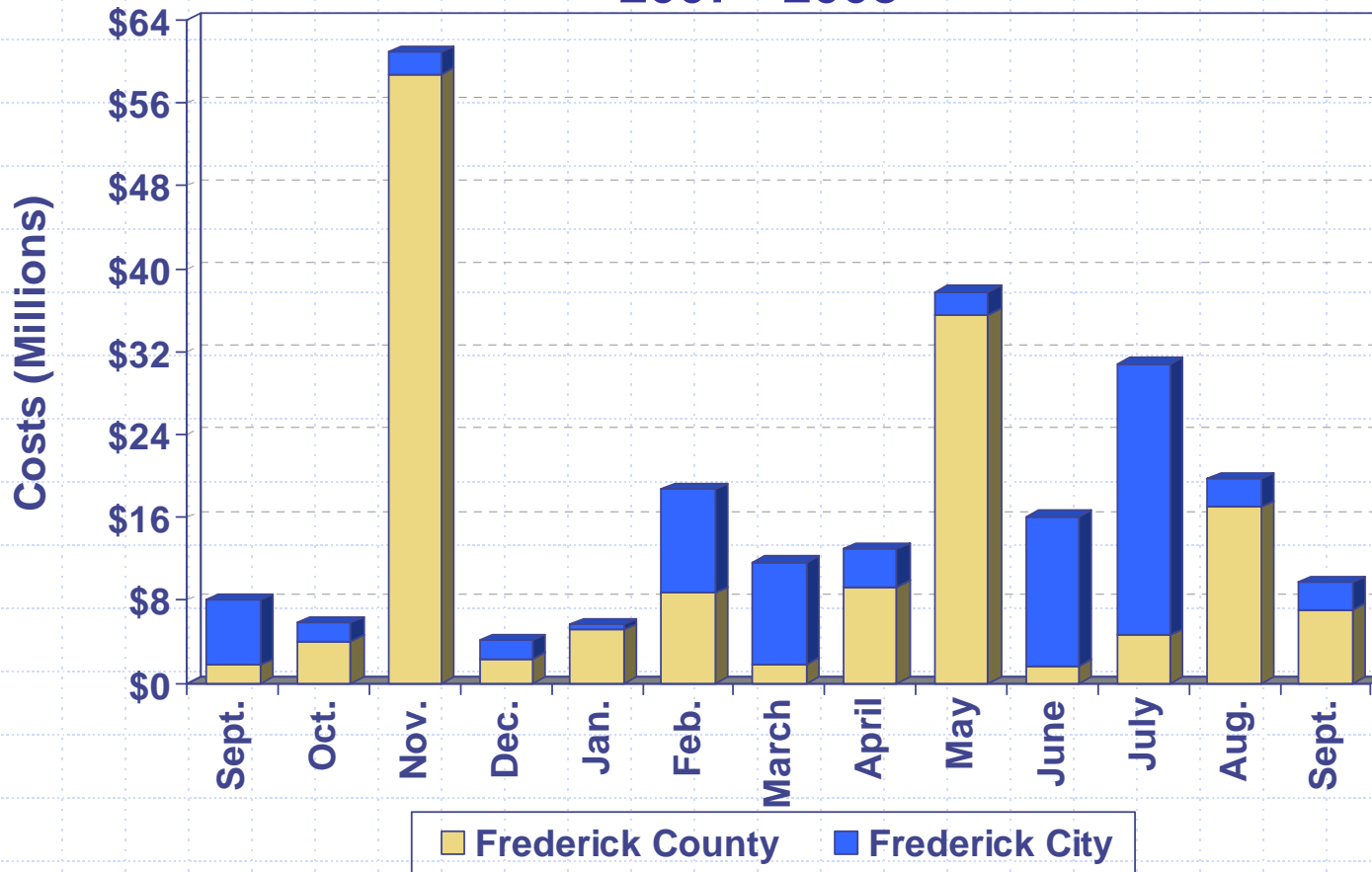
Construction Costs 2007 - 2008

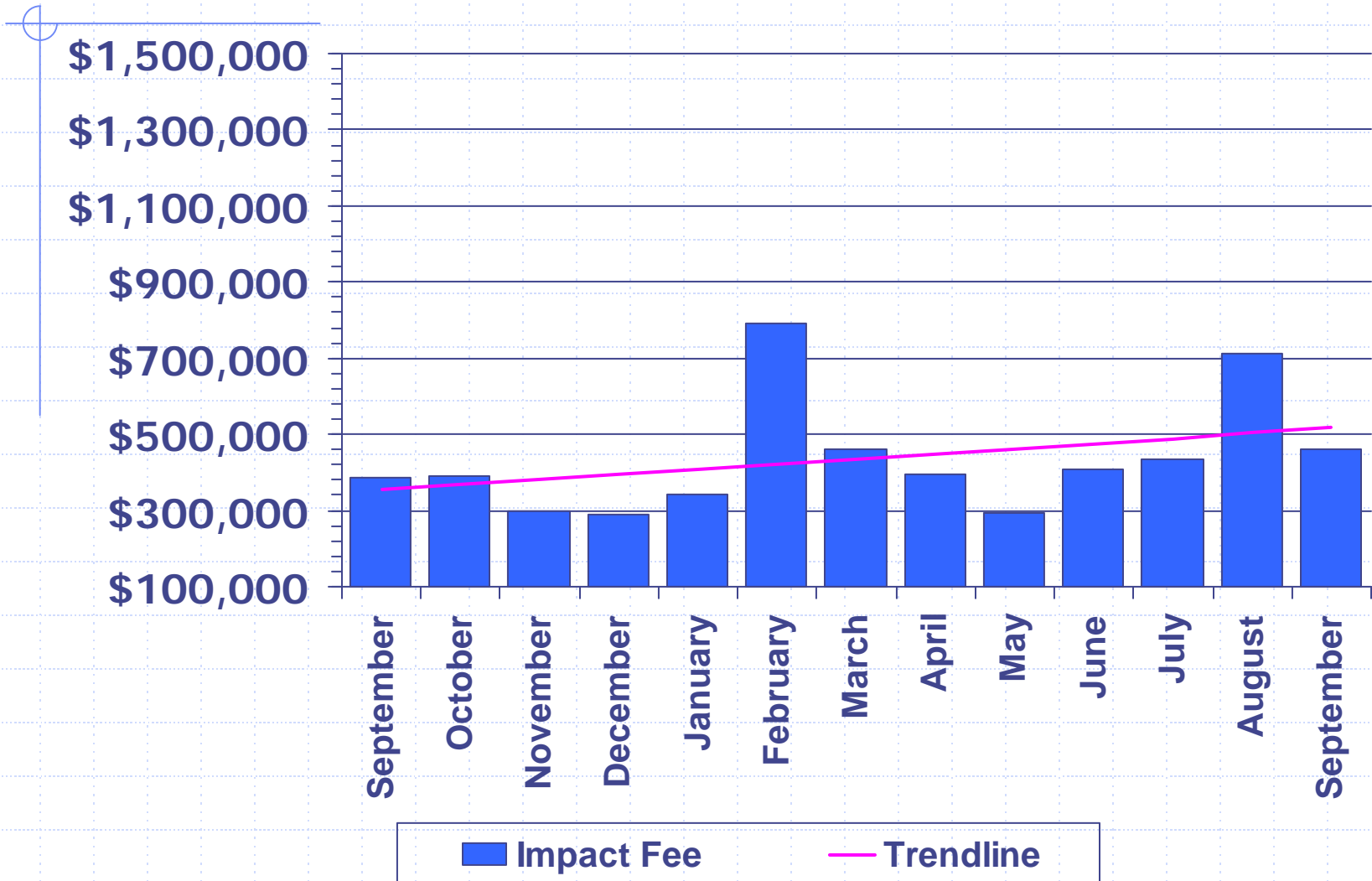

Impact Fee 2007 - 2008

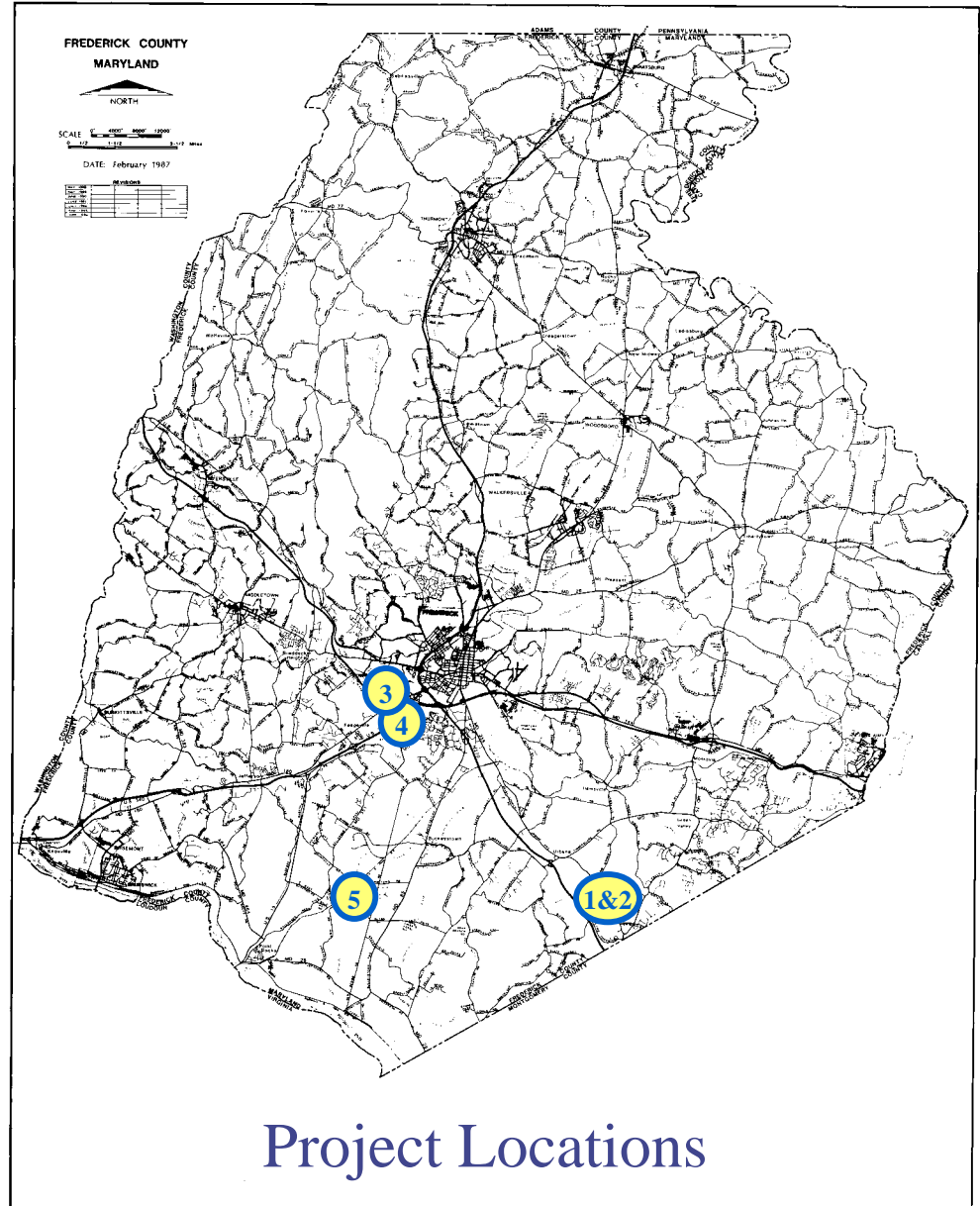

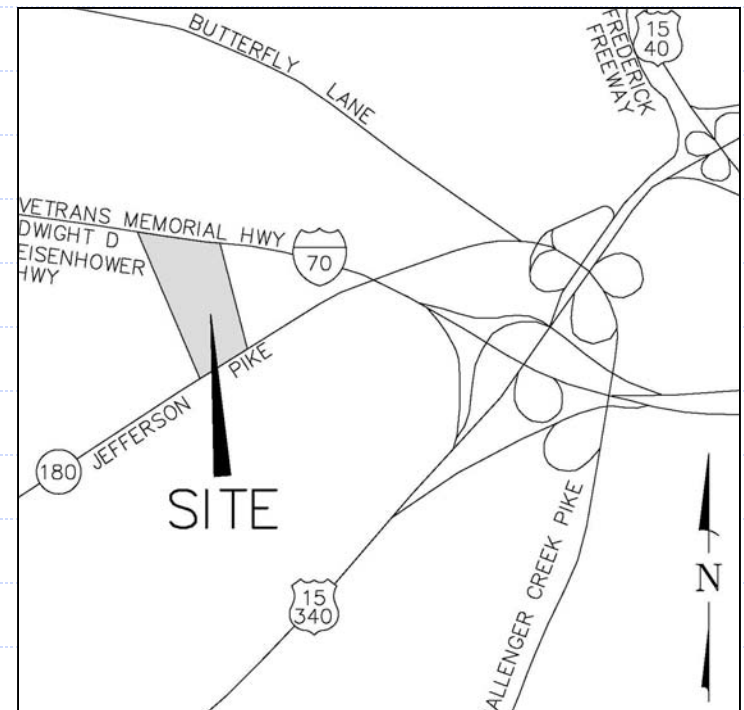
