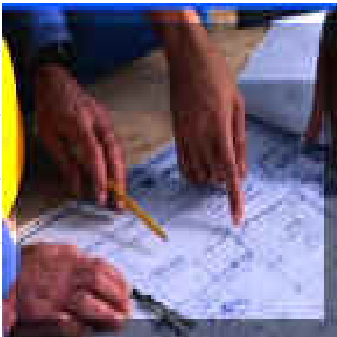


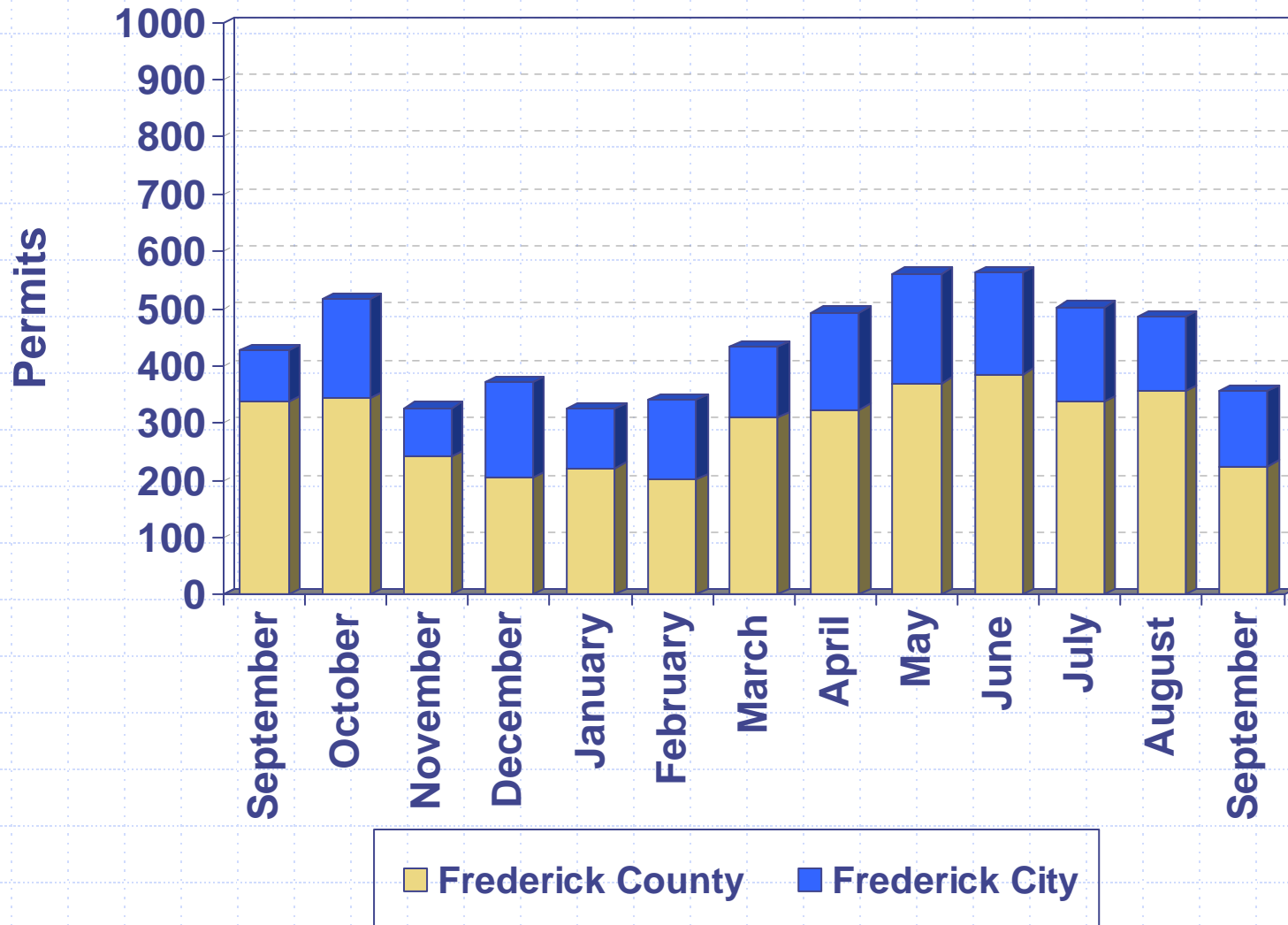

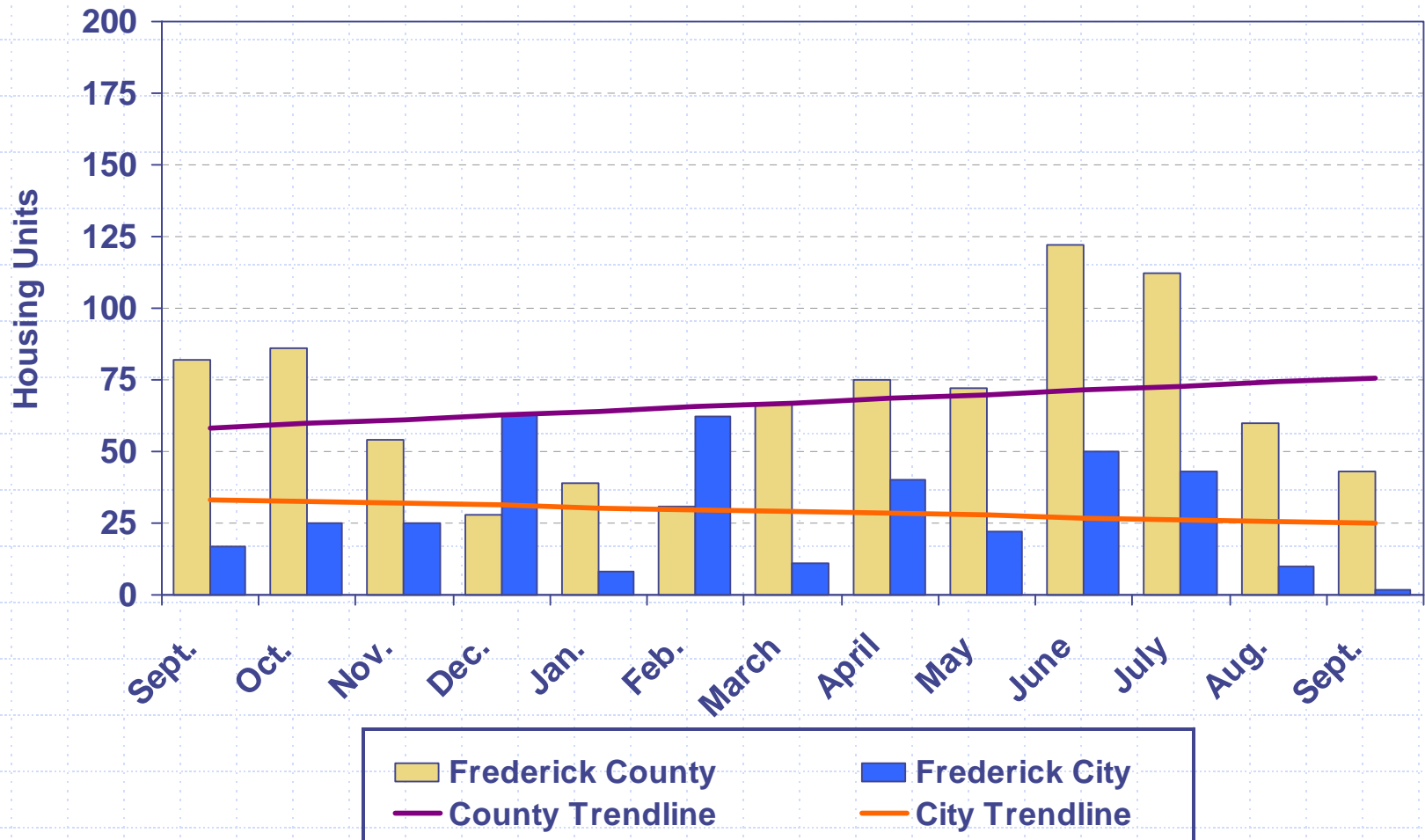


Building Permits Issued 2006 - 2007

12 Month Total (October 2006 – September 2007): 1,150 units

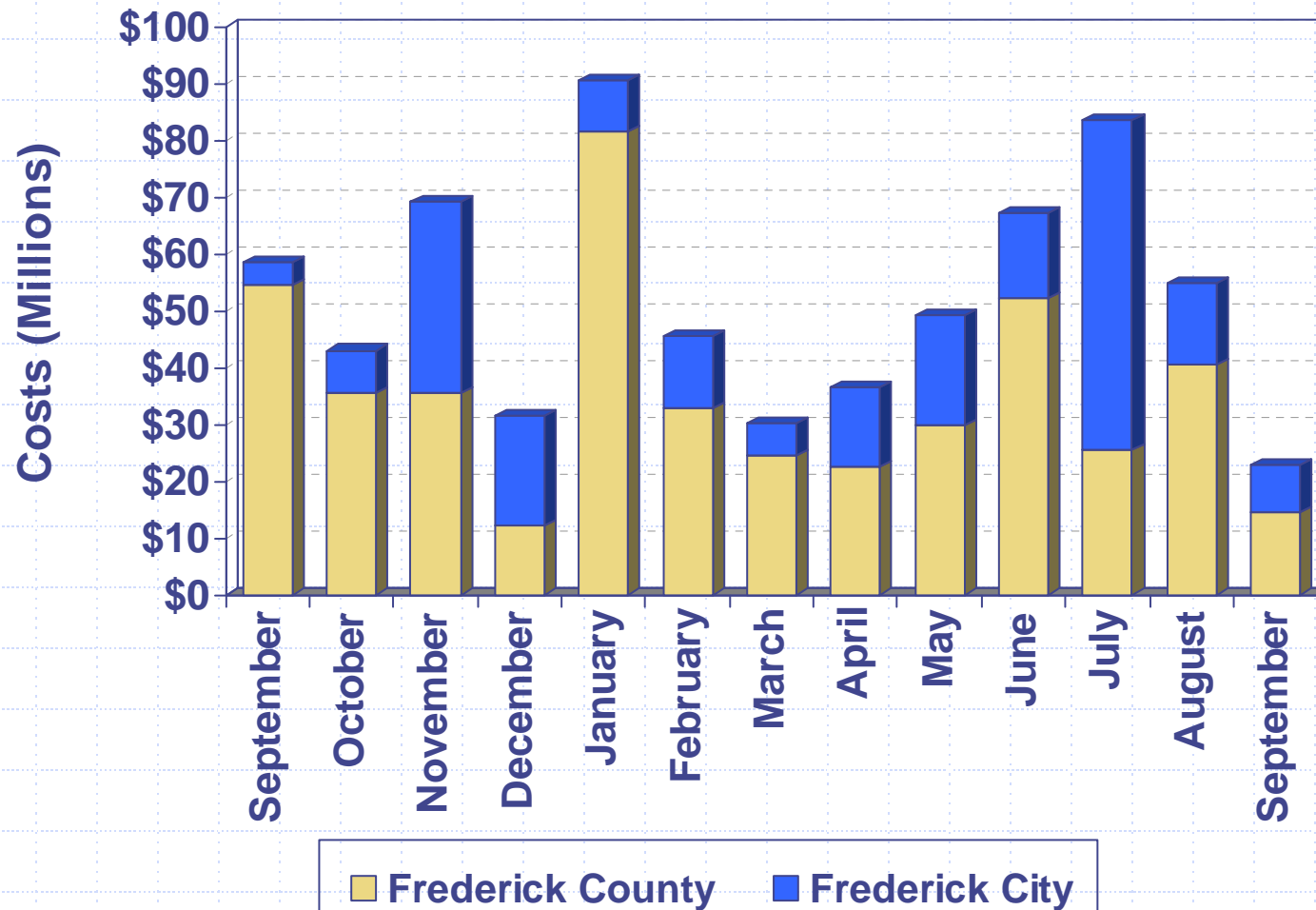

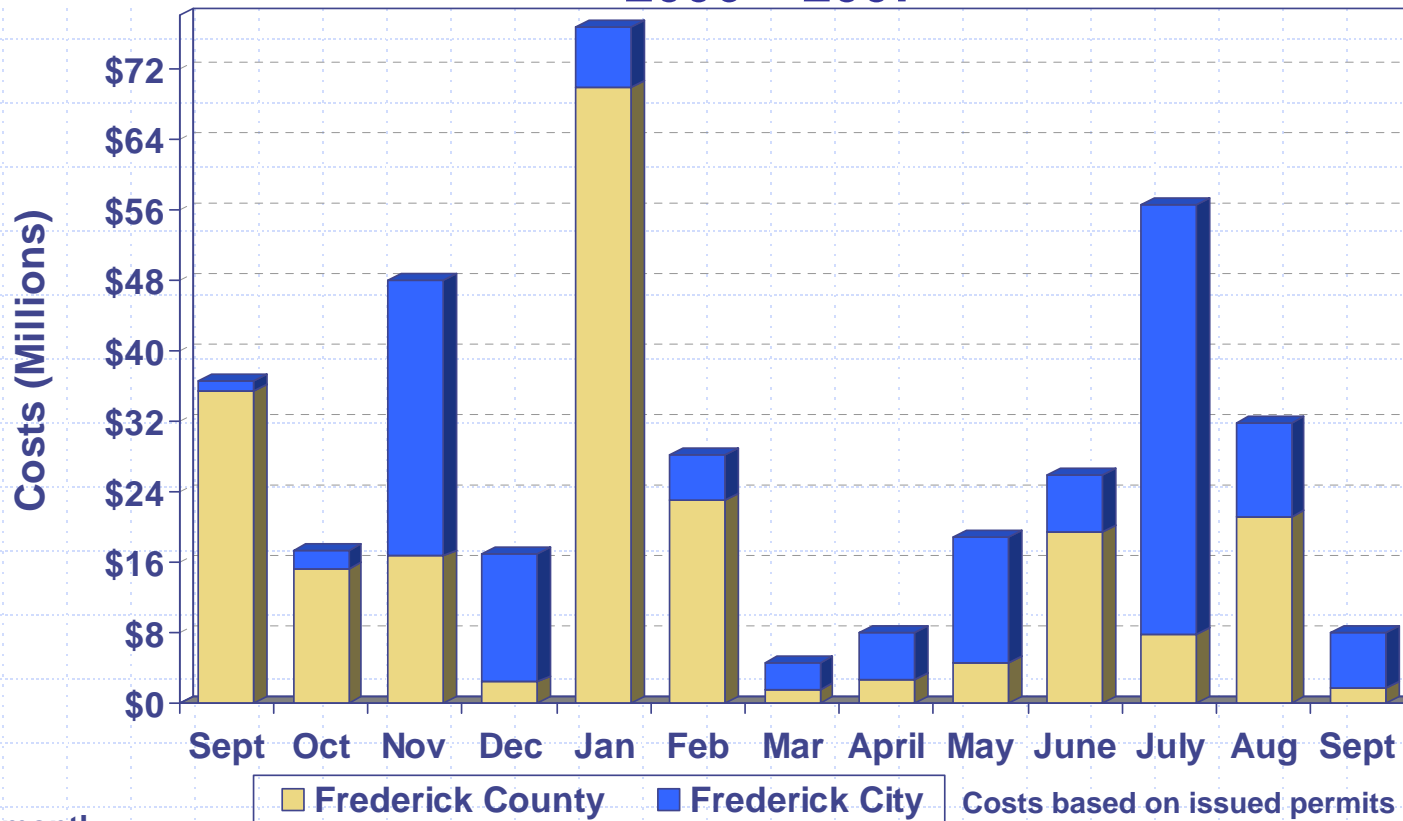
Construction Costs 2006 - 2007

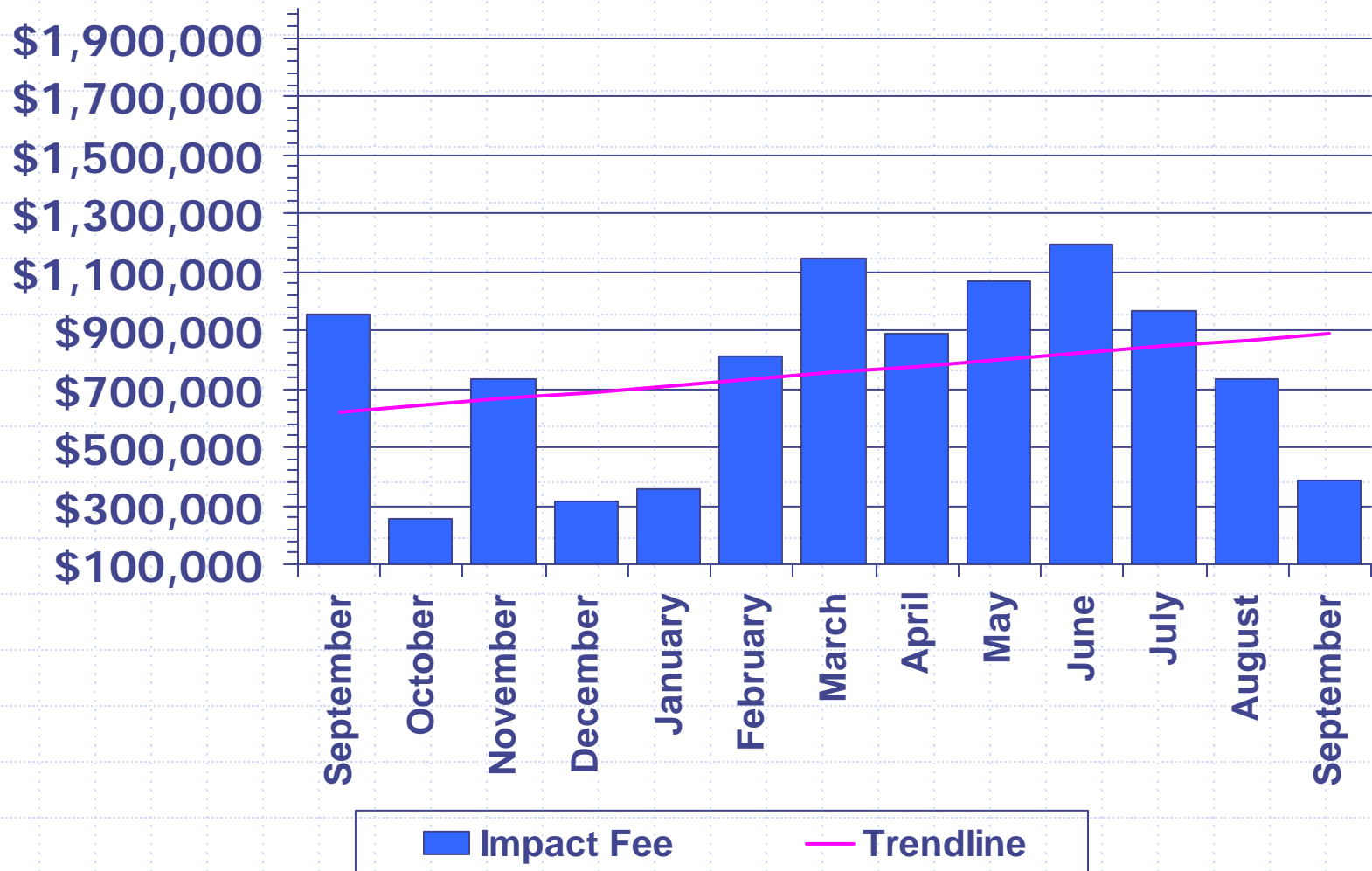

Impact Fee 2006 - 2007

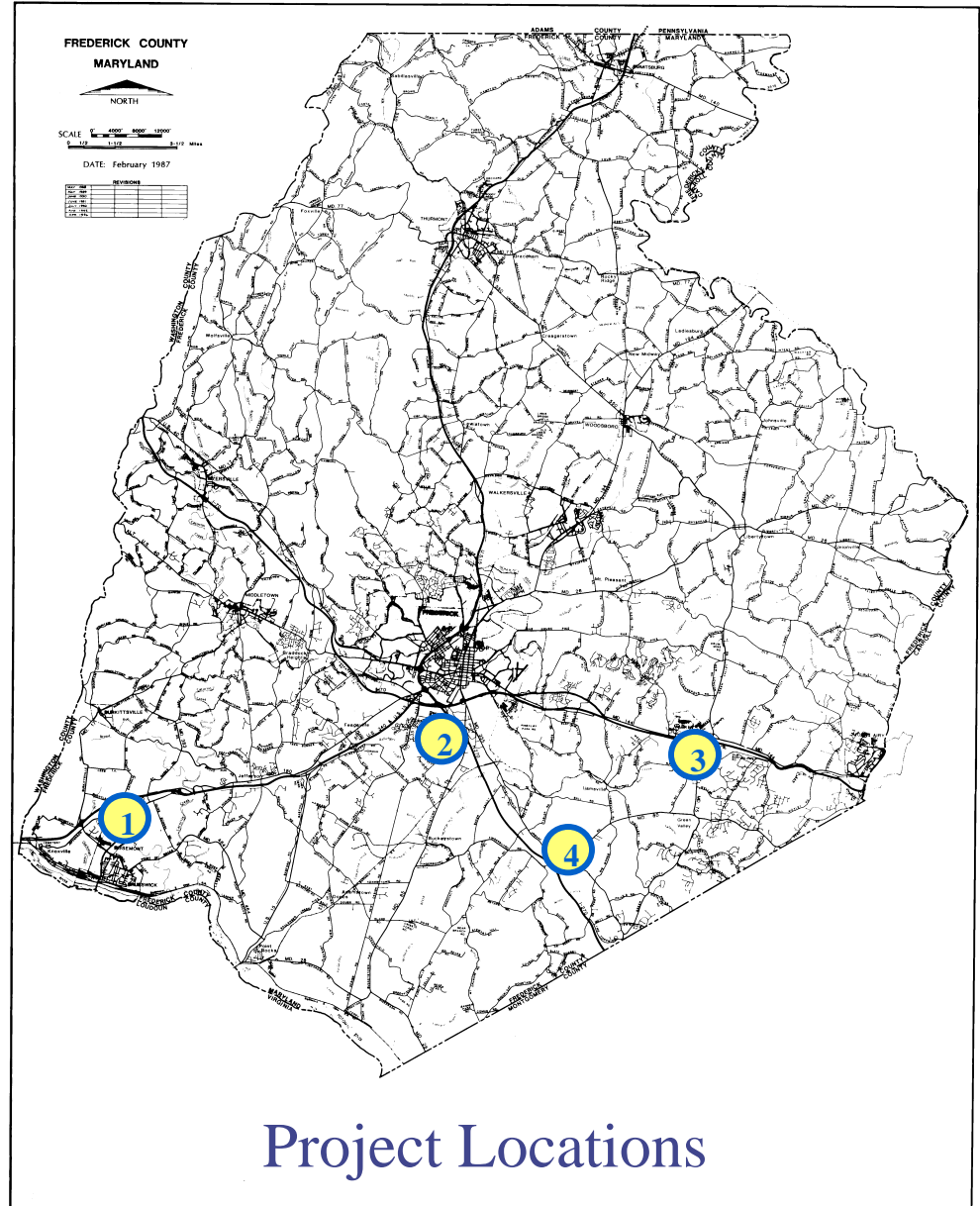

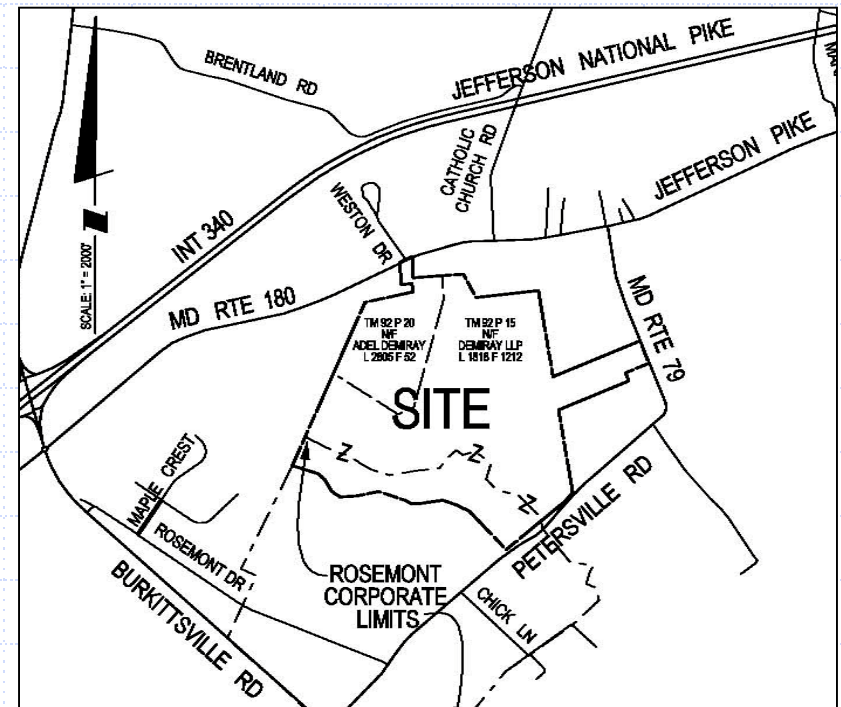

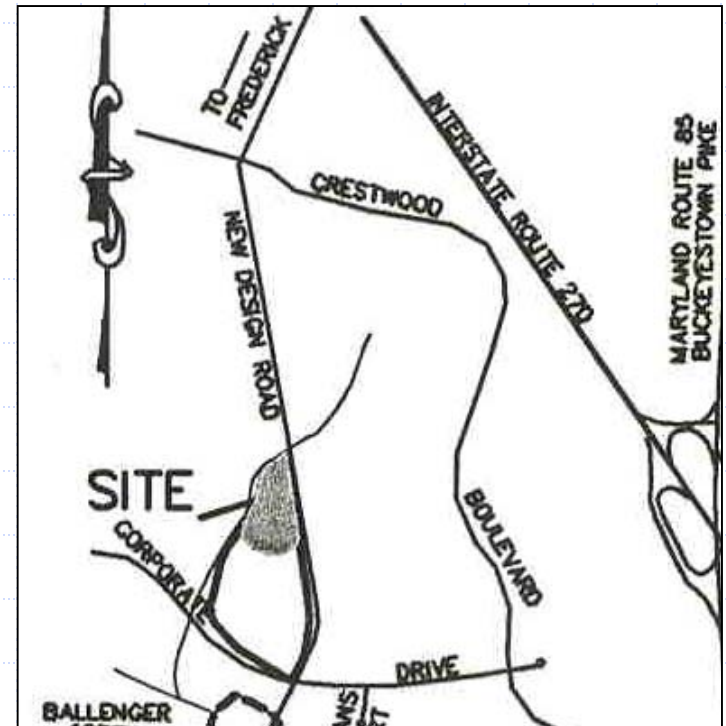


Demiray Property

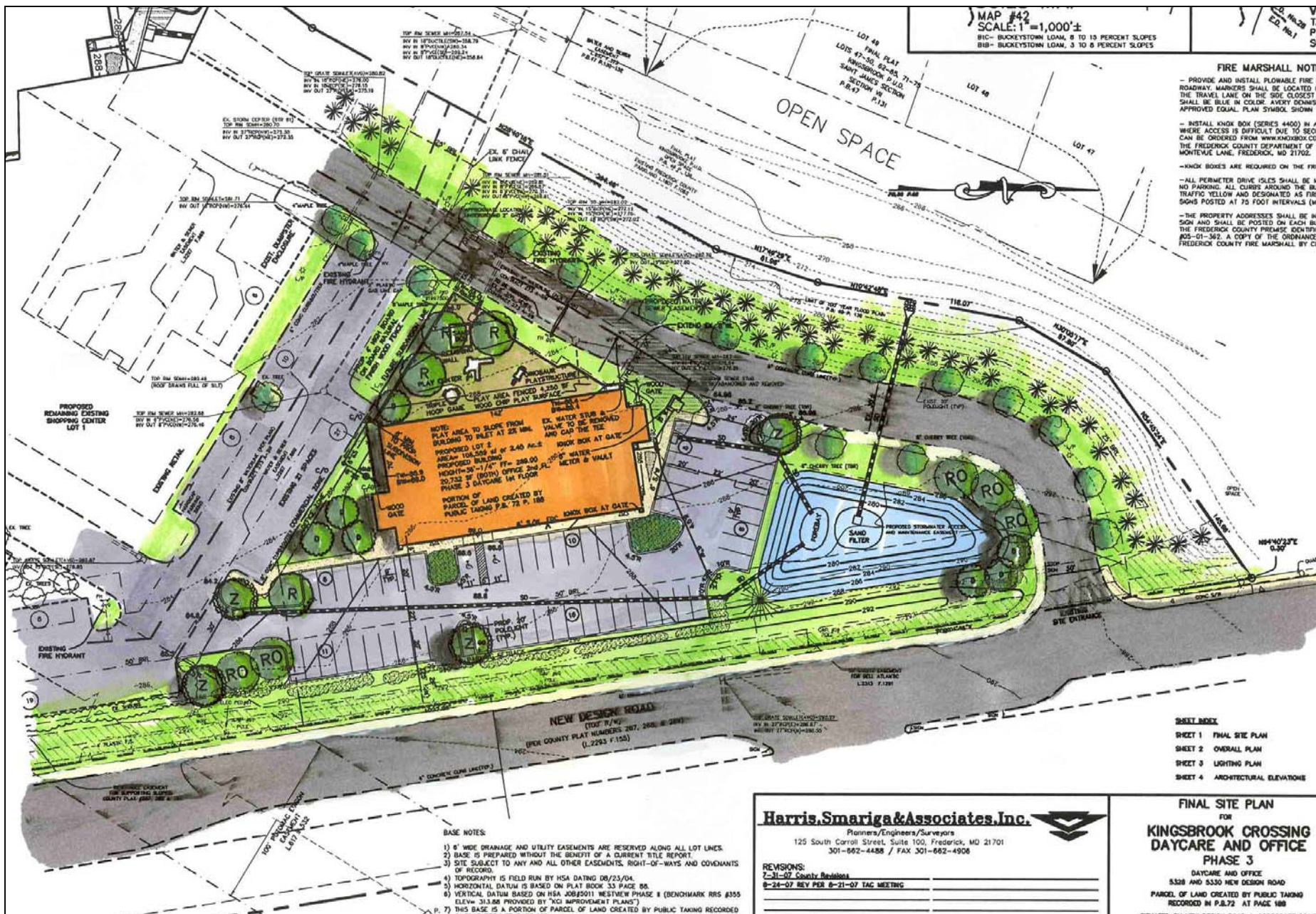


Kingsbrook Daycare & Office

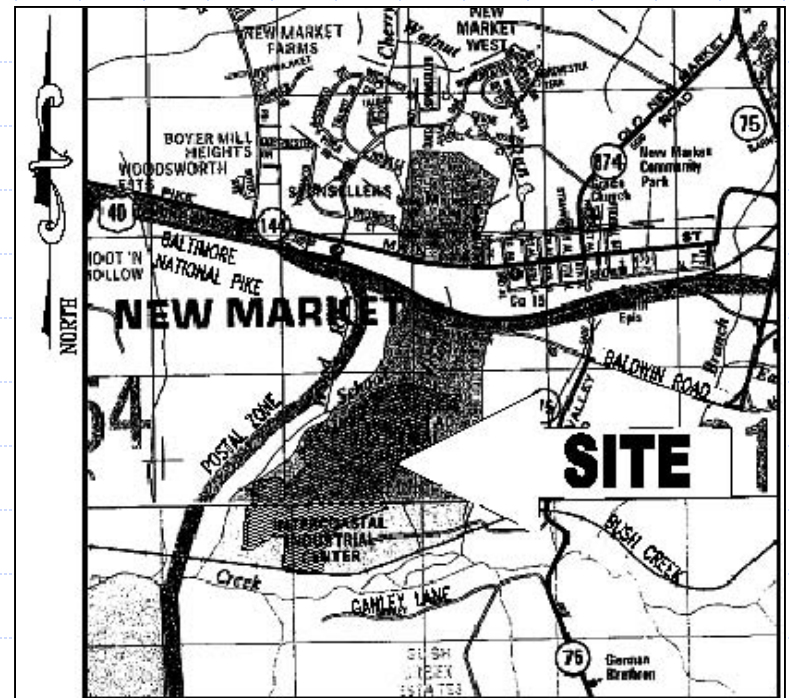
