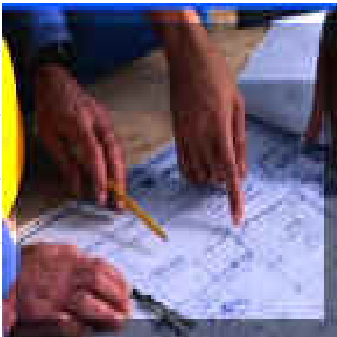


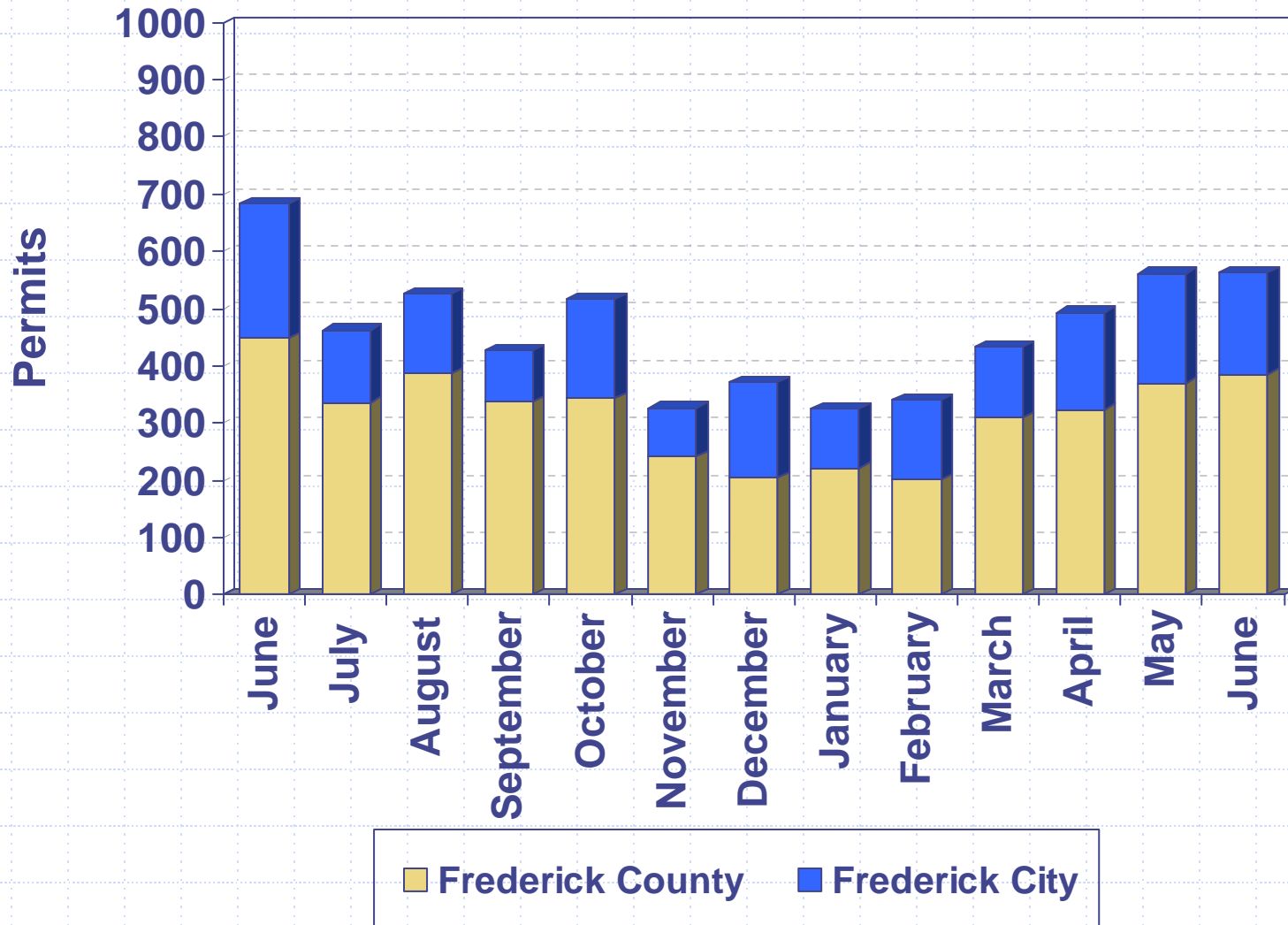

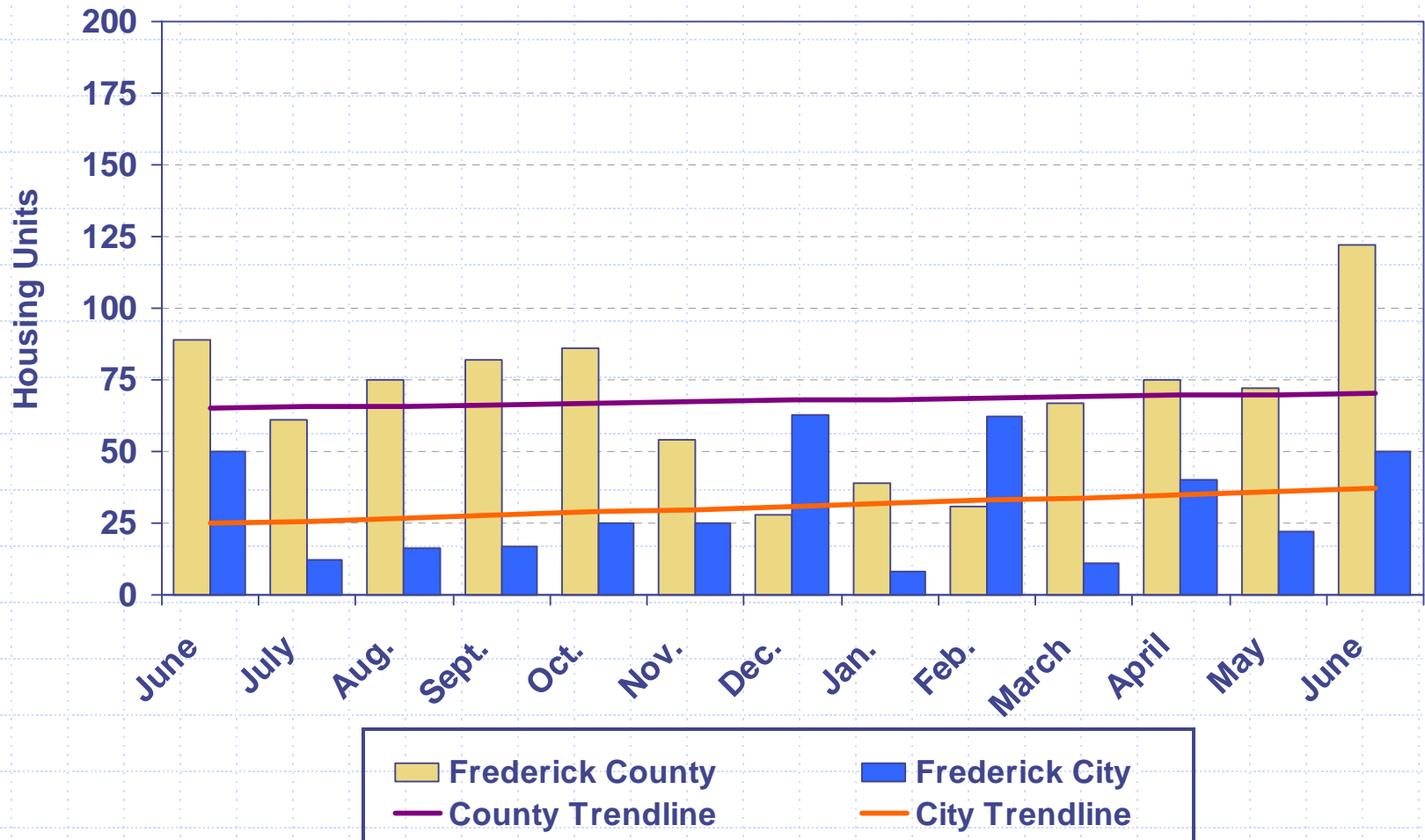


Building Permits Issued 2006 - 2007

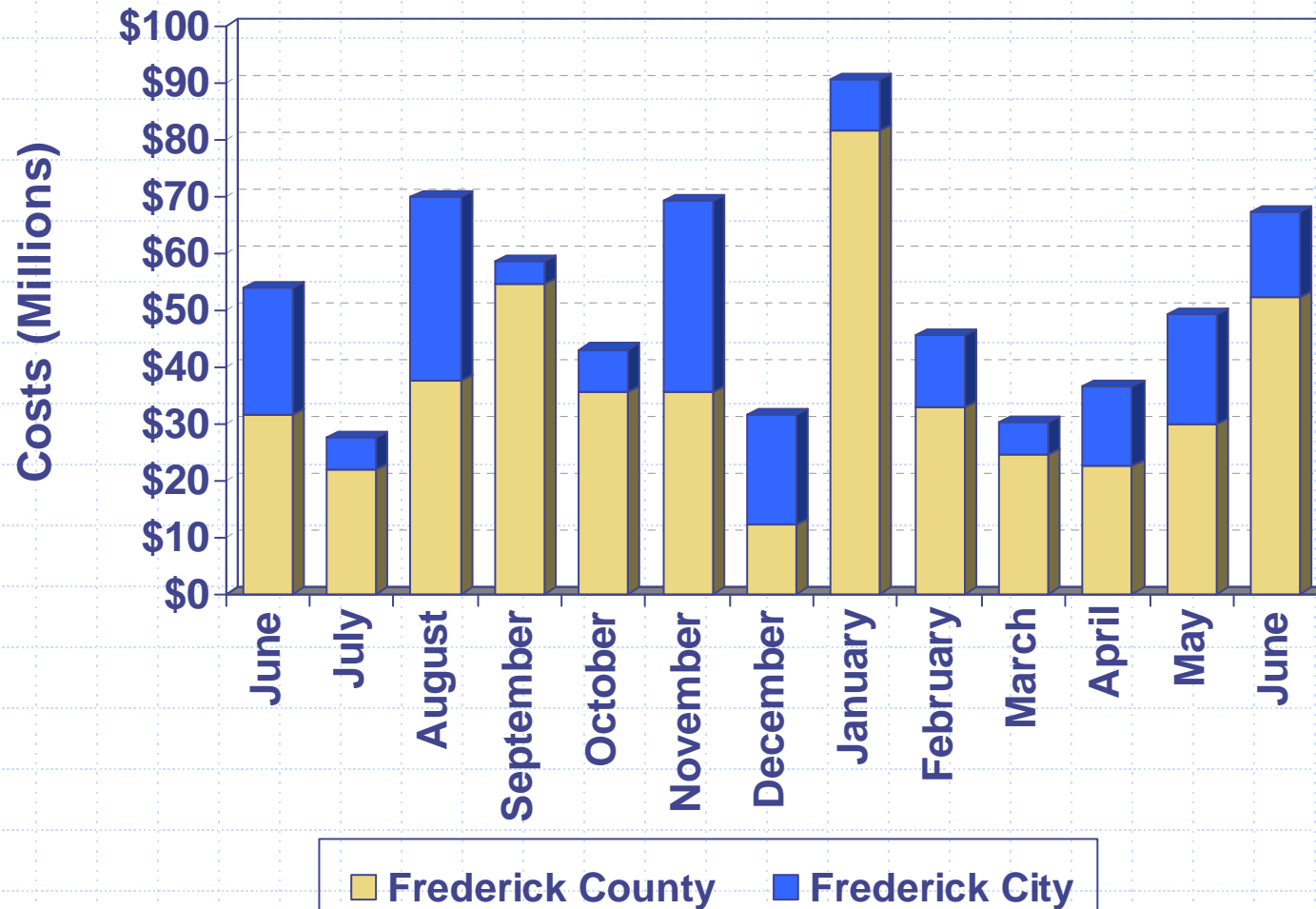

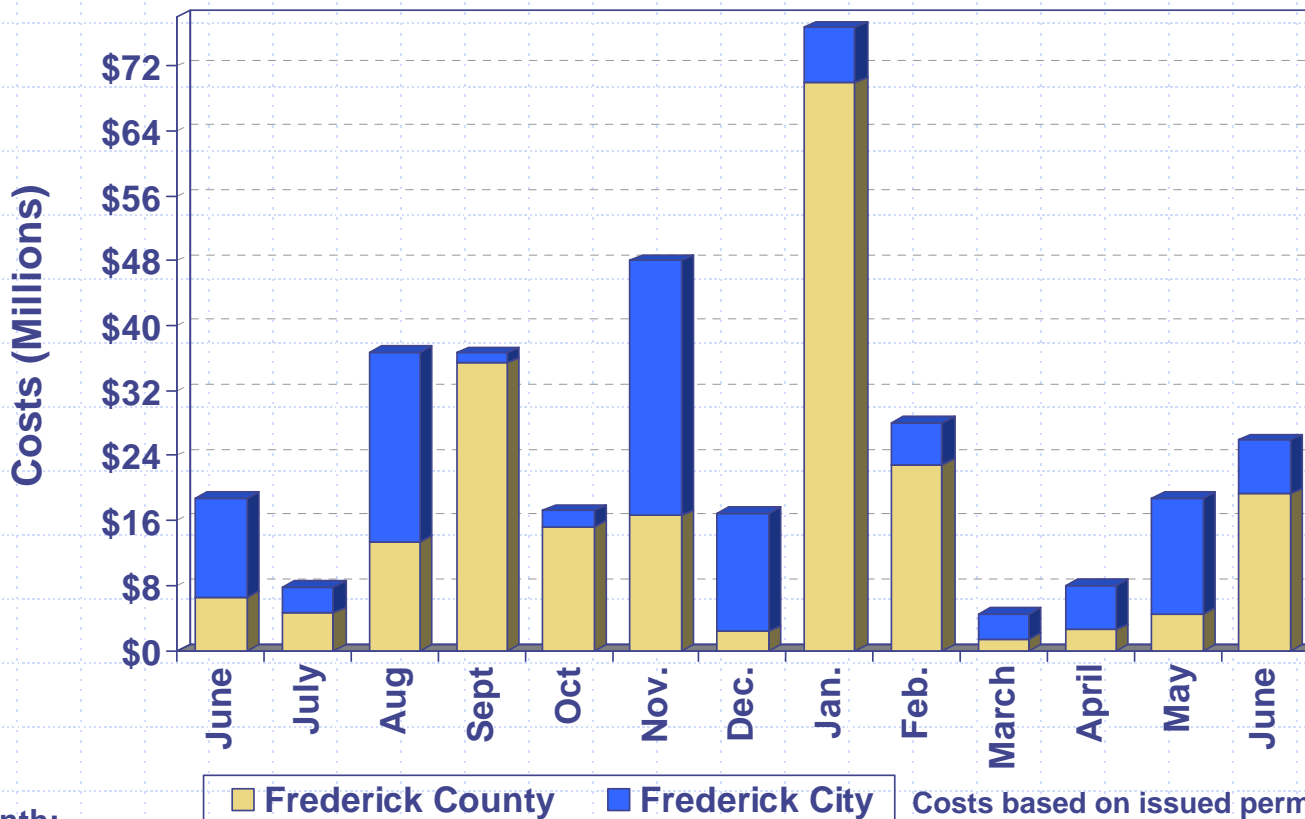

Commercial Construction Costs 2006 – 2007



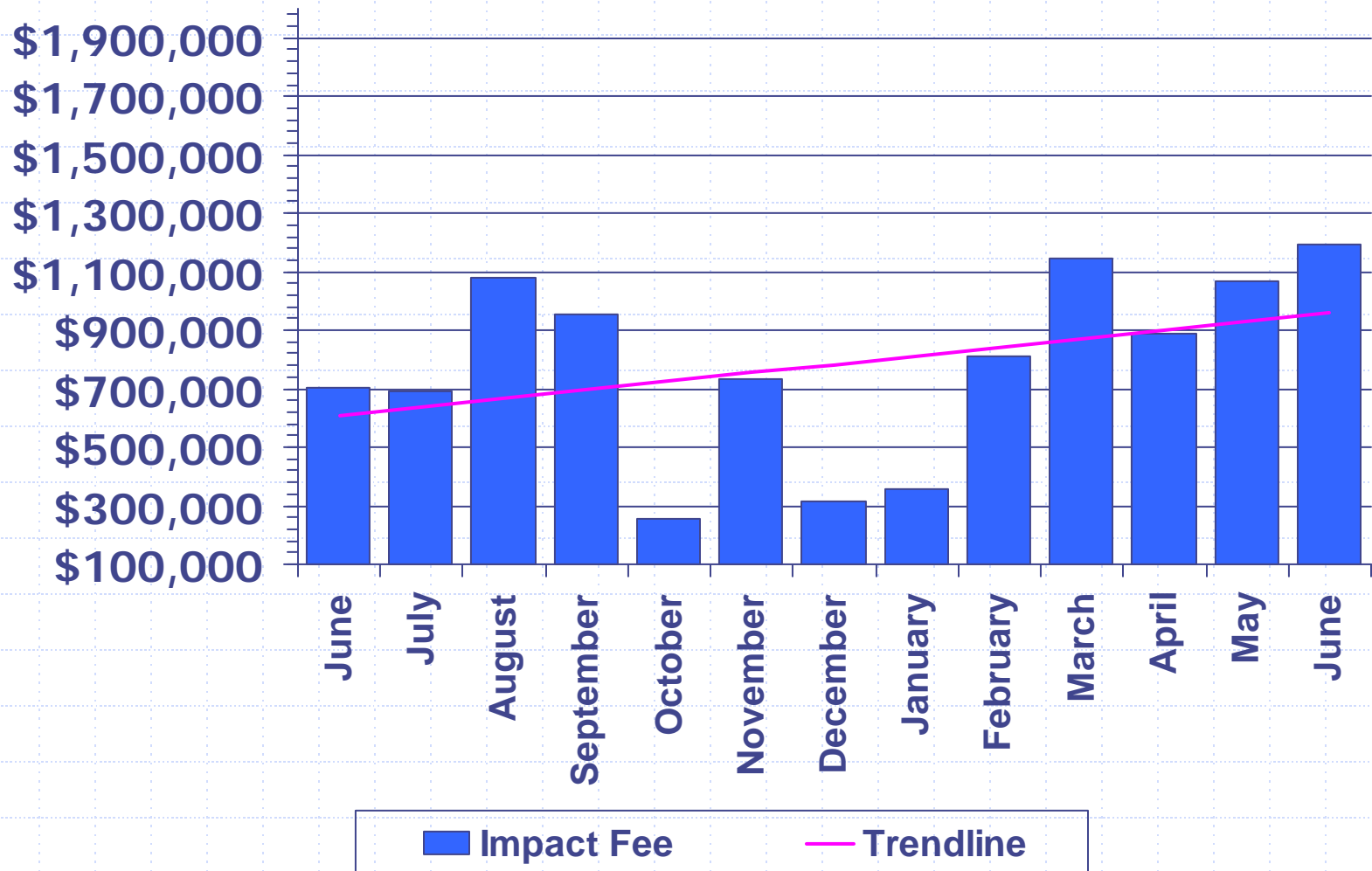

Impact Fee 2006 - 2007

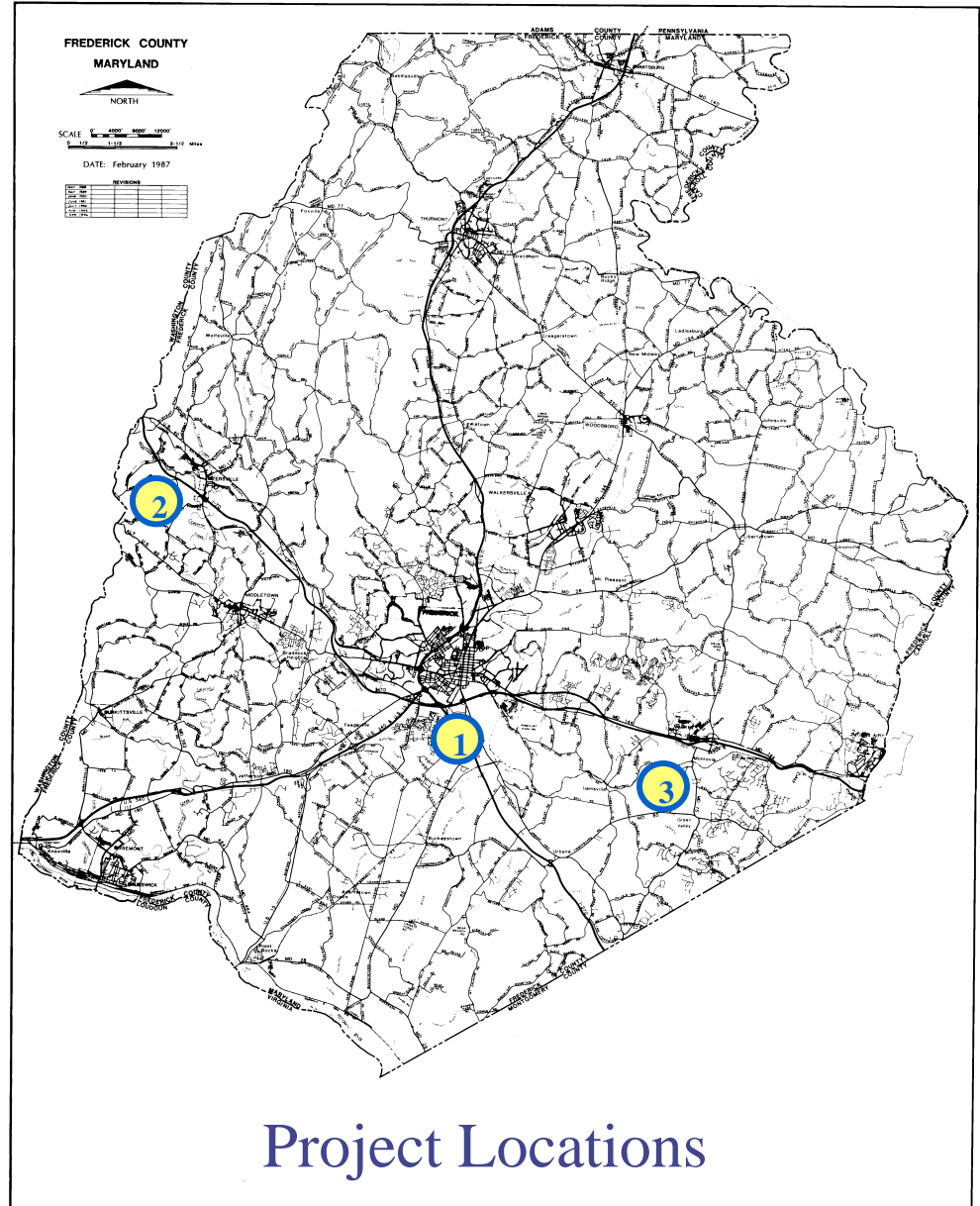
