**I. Minutes**

A. Minutes from November 22, 2021

Staff presented minutes from 11/22/2021 for review and approval.

B. Minutes from January 24, 2022

Vice Chair Bittner made a motion to approve the minutes from November 22, 2021, and January 24, 2022. Paul Spurrier seconded the motion.

**MALPF**

A. Seiss Special Occasion Events Venue

Anne Bradley presented the request for Special Occasion/ Events Venue on the Seiss property under a Maryland Agriculture Preservation Foundation (MALPF) easement. The easement property was purchased from Taylor and Brandon Huffman in December of 2021. This request falls under HB 1351, to allow the use for Special Occasion/ Events Venue on MALPF easements. Before this bill was passed, no use of this nature was allowed on MALPF easements. In order for this request to be sent for additional approval to the MALPF board, a favorable opinion by the Frederick County Agriculture Preservation Advisory Board must be rendered. One of the requirements for approval of a Special Occasion/ Events Venue on a MALPF easement property is for the applicants to be a full-time farmer requirement, meaning the applicant has a majority of their income derived from farming during the past three years. Staff requested the applicant provide 3 years of tax returns showing this requirement. The applicant declined to do so. Another requirement is that the special occasion events venue will not interfere with the agricultural use of the easement. Agriculture will not be the primary use of the barn.

- E. CREP Anne Bradley presented that there is still a lot of interest in this program and that the current amount per acre is still at \$5,500.
- F. Inspections Update Beth Ahalt presented that staff has been working on inspections and are projected to be completed with all of the MALPF/FRPP inspections by the end of April.
- G. Other Violation Updates Beth Ahalt presented that staff has been working with the Zoning Department to rectify 7 violations on IPP easement properties.
