## **CANDIDATES ASKED TO REMOVE ELECTION SIGNAGE AT END OF EARLY VOTING**

FREDERICK, MD – Frederick County Board of Elections officials today reminded candidates of the requirement to remove all their signage at Early Voting locations immediately after the centers close on Thursday, June 19, at 8:00 p.m. Signage still at these locations at the time they open to the public on Friday, June 20, will be discarded.

Early voting locations are currently open each day from 10:00 a.m. through 8:00 p.m. until June 19 at three locations – the Frederick County Senior Center (1440 Taney Avenue, Frederick, Md.), the Thurmont Regional Library (76 East Moser Road, Thurmont, Md.) and the Urbana Regional Library (9020 Amelung Street, Frederick, Md.).

Signs cannot be closer than 100 feet from the entrance to a voting location and cannot block access to the building.

As an additional reminder, election officials said that signage can only be posted on private property, not on public rights-of-way. The Maryland State Highway Administration further requires that political signs may not be placed in the median, along the shoulder or anywhere else within right-of-way, just as other advertising signs are prohibited.
