A task force is hereby established to make recommendations to the County Council and the County Executive regarding the following:

1. *Developing coordinated anti-human trafficking efforts in Frederick County through community protocol development, extensive community outreach, proactive investigation, training, intelligence sharing, and the formation of partnerships between law enforcement and non-governmental organizations;*
2. *Identifying vulnerable populations and increasing identification of human trafficking victims in Frederick County, including domestic and transnational victims of both sex and labor trafficking;*
3. *Aiding in the establishment of a provider network to provide comprehensive services to victims of trafficking; and*
4. *Increasing identification and prosecution of all parties supporting the organized efforts that engage in human trafficking to include traffickers, suppliers, transporters, advertisers and demand elements.*
