I will <b>NOT</b> leave for any reason at any time during Early Voting or Election Day until dismissed by the chief judges.</li> <li>• I agree to be courteous, respectful and to assist <b>ALL</b> voters regardless of national origin, race, creed, gender, age, physical challenge or proficiency in the English language.</li> <li>• I am prepared to fulfill my responsibility to conduct the election according to federal, state and local election laws.</li> <li>• I will not use my personal cell phone while polls are open at Early Voting or on Election Day, unless I am authorized to do so by a chief judge.
