MINUTES of the February 6, 2019 Monthly Meeting of The Frederick County Board of Elections

The meeting was called to order at 12:31 PM, in Room 119 of the Frederick County Board of Elections Office, located at 340A Montevue Lane, by the Board President, Mrs. Mary Lou Green.

Sydnee Sichert, Legislative Analyst for the County Council attended the meeting on behalf of the Council. Deborah Carter, Democratic Central Committee Chair attended the meeting.

APPROVAL OF MINUTES FOR JANUARY 10, 2019 MEETING:

Mr. Woodcock made a motion to accept the minutes. Mr. Jeffers seconded the motion, and it passed unanimously.

COUNCIL LIAISON COMMENTS:

Mr. Harvey expressed appreciation for Ms. Sichert's attendance on behalf of the Council Liaison.

ELECTION DIRECTOR'S REPORT:

Mr. Harvey reports post-election maintenance is complete. Training will address issues with packing of voting booths by election judges. Bill hearings are ongoing at the Maryland General Assembly.

OLD BUSINESS

FY19 BUDGET:

Mr. Harvey provided an overview of the current status of budget accounts. The General Office fund has sufficient funds. The Early Voting and General Election funds are still in positive status. The Board discussed the underfunding of the State Overtime sub-account.

2018 ELECTION JUDGES:

Ms. Winer reports judges have been paid. 106 no-show judges (approximately 12.5% of 849 hired), majority of these were college students who didn't officially withdraw for the general election. No-shows were marked as "do not hire" but an exception will be made for college students. Procedures will change to re-verify availability between Primary and General elections in 2020. The Board discussed judges dissatisfied regarding taxes on their pay. Some people were in danger of losing social

service benefits because they are being considered a county employee. The Board discussed the chief judge recap meeting and found the feedback useful.

MANUAL AUDIT:

The manual audit was completed on January 24, 2019. The results of the audit matched the results from the voting system. Staff audited an Election Day precinct 21-002, the Thurmont EV site, absentee, and provisional ballots. 1142 ballots were audited.

2019 GENERAL ASSEMBLY SESSION:

Mr. Harvey provided an overview of the elections-related bills filed as of this meeting.

HB79/ SB461	Increases EV locations, probably won't impact Frederick County until 2022.	MAEO supports with amendments. Likely to pass.
HB119	Allows voters to request permanent ABS status.	MAEO no position. Likely to pass.
HB172	SBE bill. Rolls back voter registration deadline from 9pm to 5pm.	
HB237	EV hours change for general elections. Changes to 8am for all.	MAEO opposes. Likely to pass.
HB252	Assists eligible detainees with VR and ABS.	MAEO no position.
HB269	Pre-paid postage for ABS ballots.	MAEO suggests language change to require SBE to reimburse costs. Likely to pass.
HB286	Same-Day Registration on election day.	MAEO will comment on costs.
HB322 /SB606	Changes terminology from ABS voting to "Vote By Mail".	MAEO no position, but may ask constitutional terminology re ABS. Likely to pass.
HB423	Creates High School Voter Registration system.	MAEO suggests amendments making sure staff/students are aware of OLVR.
HB530 /SB489	Allows unaffiliated to affiliate at EV and ED.	MAEO opposes.
HB565 /SB373	Changes process to BMD only.	MAEO opposes due to fiscal impact, and audit implications.
