The County Council of Frederick County, Maryland finds it necessary and appropriate to revise the tax rates set forth in the Frederick County Code, Section 1-8-104, for the Braddock Heights, Libertytown, and New Addition electric lighting districts, which are special taxing districts, as shown in the attached Exhibit 1, such revised rates to be effective July 1, 2020.

NOW, THEREFORE, BE IT ENACTED, that the Frederick County Code be, and it is hereby, amended as shown on the attached Exhibit 1.

**CHAPTER 1-8: LIGHTING DISTRICTS**

\*\*\*\*\*

§ 1-8-104. ELECTRIC LIGHTING DISTRICT TAX RATES.

(A) A special district tax shall be levied on all assessable real property within the established electric lighting districts as follows.

- (1) Braddock Heights: \$[0.015] 0.010 per \$100 of assessed value.
- (2) Libertytown: \$[0.013] 0.010 per \$100 of assessed value.
- (3) New Addition: \$[0.017] 0.010 per \$100 of assessed value.

(B) The tax rates established shall continue in effect each year hereafter until changed by the county governing body.
