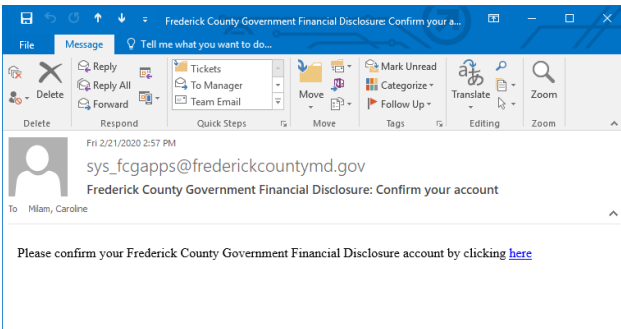


Frederick County Government Annual Financial Disclosure Guide for External Recipients
