CHAPTER 1-2: ADMINISTRATION

ARTICLE XVI. SMALL BUSINESS ADVISORY COMMISSION

§1-2-600. Creation, Duties.

(A) There shall be a Frederick County Small Business Advisory Commission hereinafter referred to as “the Commission”.

(B) The Commission shall act as an advisory body that serves as a means for small businesses to be heard and understood, facilitate civic engagement, and legitimize issues of importance to small businesses operating in Frederick County,

(C) Among its responsibilities and duties the Commission shall:

- (1) Advise the County Executive and the County Council on ways to enhance and improve the business climate for small businesses in Frederick County;
- (2) Represent the views and the needs on behalf of the small business community;
- (3) Monitor, analyze, and make recommendations for existing or proposed policies and actions at all levels of government for their impact on small businesses;
- (4) Review existing Frederick County Ordinances for recommended changes to improve the business climate in Frederick County;
- (5) Review regulations and make recommendations on issues under the authority of County Government that could be altered to enhance the business climate for small businesses in Frederick County;”
- (6) On or before July 1 of each year, the Commission shall submit an annual report to the County Executive and County Council. The report shall include recommendations as identified above.

2 (D) Two years following the first meeting, the Commission will submit a status
3 report to the County Executive and County Council. The report should include
4 assessment findings and recommendations as identified above. Upon submission of this
5 report, the County Executive and County Council may submit questions or requests to
6 the Commission for additional information. The Commission will have eight weeks to
7 respond to any requests. Upon completion of this review, the Council must vote whether
8 to reauthorize the Commission.

10 **§1-2.601 Composition.**

11 (A) Subject to the confirmation of the County Council, the County Executive must appoint
12 the following individuals to serve on the Commission for a three-year term unless
13 otherwise noted:

- 14 a. One member selected by the Frederick County Chamber of Commerce;
- 15 b. One member selected by the Downtown Frederick Partnership;
- 16 c. One member selected by a non-profit entity that advocates on behalf of small
17 businesses;
- 18 d. One member selected by the Frederick Farm Bureau;
- 19 e. One member selected by the Business Law Section of the Frederick County Bar
20 Association;
- 21 f. One member of Visit Frederick;
- 22 g. Two members belonging to municipal business organizations;

23 (B) The following individuals shall serve as ex-officio, non-voting members with no terms
24 assigned:

- 25 a. A member of the County Council;
- 26 b. A member of the Frederick County Office of Economic Development.

27 (C) Members of the Commission shall continue to serve until their replacement is confirmed
28 by the County Council.

3 (D) A County staff member may be designated by the County Executive to assist and support
4 the Commission.

7 **§1-2-.602 Chair, Vice-Chair.**

9 The Coordinating Council must elect a chair and vice-chair from among its members to
10 serve 2-year terms.

11
12 **§1-2-.603 Rules.**

13
14 The Coordinating Council shall adopt rules to govern its procedures and activities.

15
16 **§1-2-.604 Compensation.**

17
18 Members of the Coordinating Council shall receive no compensation for their services.

19
20 **§1-2-.605 Meetings and Quorum.**

21 (A) The Commission shall meet with the frequency it determines necessary to perform its
22 functions but there shall be no less than four meetings annually.

23
24 (B) A majority of the Commission members shall constitute a quorum for the transaction of
25 regular business.
