## REDISTRICTING COMMISSION PROPOSAL: PUBLIC HEARING NOTICE

The Frederick County Council will be holding a Public Hearing regarding the recommendation of the Redistricting Commission on Tuesday November 30 at 7p.m.

The Commission was charged with reviewing and making recommendations concerning the existing Council Districts, ensuring that they are compact, contiguous, substantially equal in population, and have common interests as a result of geography, occupation, history, or existing political boundaries.

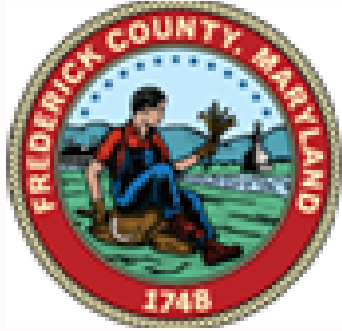
Over the last several months, the Redistricting Commission met to discuss and finalize a newly proposed District map.

## PROPOSED CHANGES



The Commission proposed moving Precinct 08-001 (Libertytown) with population size of 2,600 and Precinct 19-001 (Unionville/Linganore Grange Hall) with a population of 1,830 from Council District 2 into Council District 5. The chart below illustrates the current District populations and percentage of total County population and the District populations after the proposed changes.

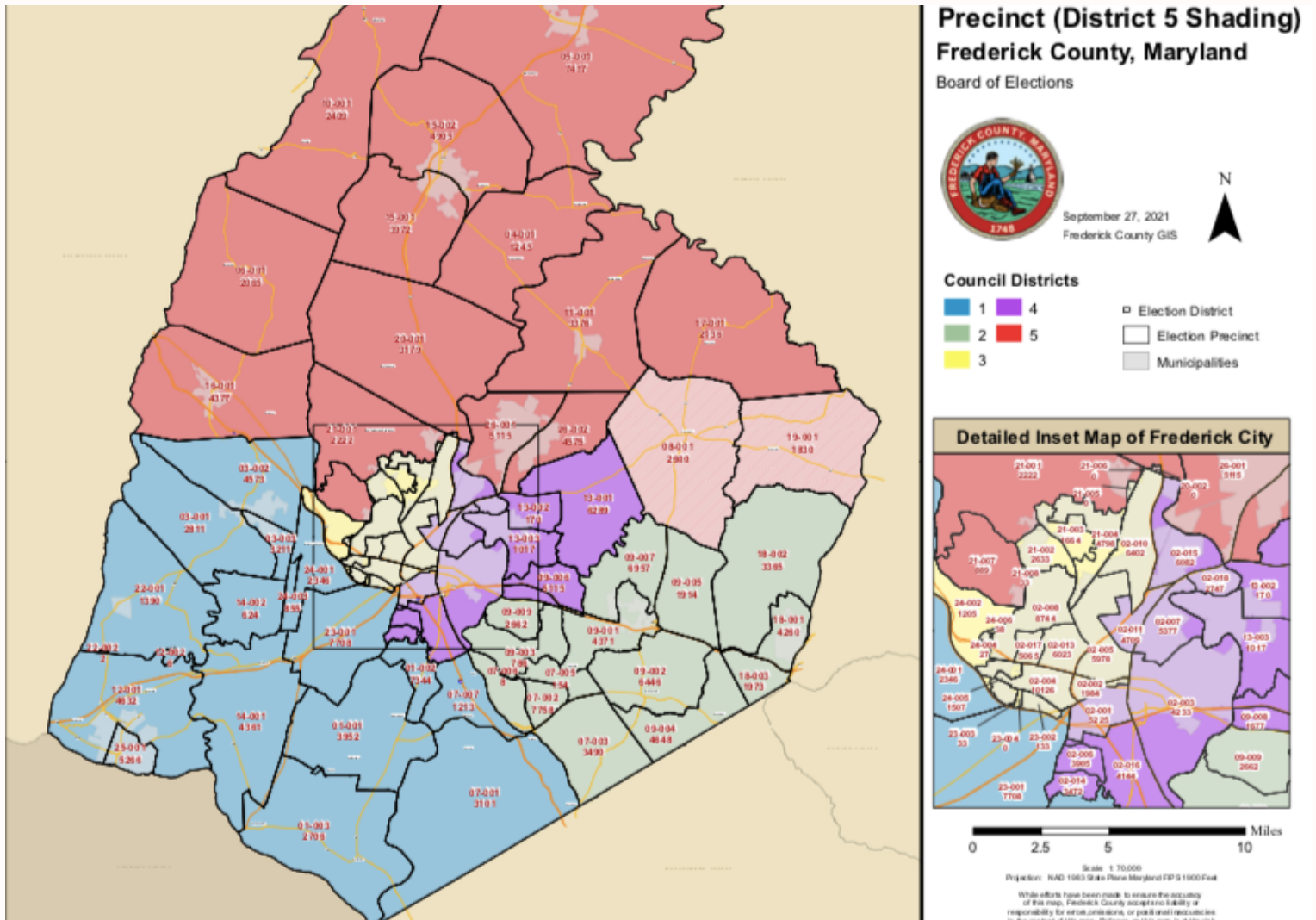
Members of the public may also give live comments. If you would like to give a public comment, call toll free 855-925-2801 and enter meeting code 8365.

To give public comment, press \*3 to be placed in a virtual line. When it is your turn to speak, you will be given three minutes to comment. If you would like to leave a recorded message to be played during the meeting, press \*2.
