## Septic System Pump-Out Rebate Program Application

Please be sure to review the instructions on the application form. If your application is missing required information, we will contact you. **If the requested information is not received within 60 days, your application will not be eligible for the program.** For questions related to this application, please email the Office of Sustainability and Environmental Resources at [SepticRebate@frederickcountymd.gov](mailto:SepticRebate@frederickcountymd.gov).

**\*Please note:** You are only eligible for a rebate once every five years, from date septic pumped, per address.

### Instructions to Apply:

1. Select a licensed septic pumping company that sends its waste to a Frederick County wastewater treatment plant (WWTP). A list of approved haulers can be found on the Septic Pump Out Rebate Program website: <http://www.frederickcountymd.gov/septicrebate>
2. Complete application. **\*Note:** The **applicant** should match the individual who ordered the pump out on the hauler invoice.
3. Upload or attach a **copy** of the septic pump out invoice that shows the service performed.
4. Proof of Payment is required. Accepted proofs of payment are as follows:
  - Cancelled check (**front and back**)
  - Credit card receipt (**must show account holder's name**).
  - Invoice or "paid receipt" signed by the hauler as "**PAID IN FULL**" with a **\$0.00 balance due**.
5. Sign and date the application. **Applicant must sign the application.**

### Please Note:

- Do not staple documents
- Rebate processing may take up to 60-90 days.
- There will be a delay in processing if required information is missing or incorrect
- Rebates are available for residential septic systems that have been pumped out **after January 1, 2021.**
- **Rebate per pump-out is \$75.00, eligible once every 5 years from date septic pumped, per address.**
- Rebate is not guaranteed and is subject to funding availability and offered on first come, first-served basis.
- Additional costs associated with equipment, parts, upgrades etc. are not eligible for a rebate.

- Proof of payment is required. Proof of payment accepted:
  - Cancelled check (front and back)
  - Credit card receipt. Receipt must show the **account holder's name**.
  - Invoice or paid receipt, signed by the hauler showing that the account has been "PAID IN FULL" with a **\$0.00 balance due**.
