18 (3) If a Plan or application is submitted for the moving or demolition of a site or structure
19 that the Commission considers to be of unusual historic value and no economically feasible plan
20 can be formulated, the Commission or their designee shall have 90 days, from the time it
21 concludes that no economically feasible plan can be formulated, to negotiate with the owner and
22 other parties in good faith in an effort to find a means of preserving the site or structure. If no
23 means of preserving the site or structure is agreed upon, the Plan or application shall be approved
24 unless **A PETITION FOR DESIGNATION HAS BEEN FILED WITH THE DIVISION IN**
25 **ACCORDANCE WITH §1-23-6(C) [~~§1-23-6(6) applies~~]**. If **THE COUNTY COUNCIL**
26 **VOTES FAVORABLY AND THE PROPERTY IS DESIGNATED TO THE FREDERICK**
27 **COUNTY REGISTER OF HISTORIC PLACES [~~§1-23-6(6) applies~~]**, the Plan or application
28 shall be reviewed under §1-23-7.

13 On Exhibit 1, it is hereby amended as follows:

14 **§ 1-23-9. ECONOMIC HARDSHIP**

15 Any owner seeking an exemption from the operation of the provisions of the chapter due to
16 economic hardship has the burden of proof to show by clear and convincing evidence that the
17 owner does not have the financial ability to comply with the requirements of this chapter. In
18 making its determination, the Historic Preservation Commission shall consider a justification
19 statement, [and] any additional evidence submitted by the owner, **AND SHALL GIVE DUE**
20 **CONSIDERATION TO WHETHER THE PROPERTY WAS DESIGNATED ON THE**
21 **COUNTY’S INITIATIVE, UNDER THE PROCEDURE DEFINED IN § 1-23-6(C)(6). [~~A~~**
22 ~~finding of economic hardship shall not be made in cases of intentional owner neglect or other~~
23 ~~self-created financial hardship or undercapitalization.]~~

18 [(E)] (2) Upon failure, neglect, or refusal of the property owner or other responsible
19 person, duly notified, to take the corrective action specified in the corrective action notice
20 within the time required, the Commission may request that the Director of the
21 Department of Permits and Inspections [or their designee enter the building or premises
22 affected by the order and cause the building or premises to be repaired, or cause any
23 dangerous condition to be remedied, as the case may be, at the expense of the
24 owner] **INSTITUTE ANY OF THE REMEDIES AND PENALTIES PROVIDED**
25 **BY LAW FOR SUCH VIOLATIONS.**

27 ~~[(3) If the property owner fails to repay the County for expenses incurred under~~
28 ~~subsection (D)(2) above within thirty (30) days after written demand has been mailed to~~
29 ~~their last known address, the Director of Permits and Inspections shall notify the County~~
30 ~~Treasurer and a tax lien in favor of the County for the amount of the expenses incurred~~
31 ~~under subsection (D)(2) shall attach to the property. The property may be sold at tax sale~~
32 ~~to satisfy the lien.~~
