On behalf of Governor Wes Moore and Lieutenant Governor Aruna Miller, it is my pleasure to inform you that it is our intention to award your funding request for the Fiscal Year 2023 Connect Maryland: Network Infrastructure Grant Program pending final budget authority being granted to us by the General Assembly. Specifically, we anticipate \$3,115,456 in funding will be made available to assist you with your Shentel-Frederick County. MD FTTP Project C (2023) project as outlined in your funding application. The funding source for this program is the American Rescue Plan Act of 2021, Capital Projects Fund. All requirements of the funding source must be complied with throughout the project.

In addition to the required budget action, this funding is conditioned upon execution of a Grant Agreement between Shentel Cable Television, LLC, and the Maryland Department of Housing and Community Development.
