Initial submittals may be submitted at any time. The initial submission date is the last day to submit to be on track for the associated FCPC meeting.

It is the applicant's responsibility to submit materials as provided below to enable the project to stay on schedule.

1 - Initial submissions and/or resubmission submittals will not be accepted after 12:00 pm (noon) of the date of submittal. Initial submissions and/or resubmissions submitted after 12:00 pm (noon) on the submittal date will be placed on the subsequent or appropriate submittal schedule. Submissions that do not meet the submittal requirements, which are 1) minimum submission requirements per the Zoning Ordinance, Subdivision Ordinance, and relevant submission checklists, 2) payment of all appropriate fees (see fee ordinance), and 3) include appropriate APFO and FRO applications, will be deemed incomplete and will not be accepted for review. At such time all minimum submission requirements are met, the application will be placed on the subsequent or appropriate submittal schedule.

2 - Meeting dates can vary but should be scheduled within this timeframe, excluding weekends. Applicant will be notified of the date and time of the TAC meeting.

3 - Unless otherwise specified, submission dates falling on a date upon which County offices are closed will be due the following business day.

4 - After the 2nd TAC meeting a decision will be made whether an application may be placed on a shorter review cycle. If the application meets all initial submittal requirements (see item 1), no review agency is in resubmit, and the plan is satisfactory to the planner and his/her supervisor assigned to the application this may be considered.

5 - The TAC meeting will be scheduled, unless the applicant notifies the project planner that the TAC meeting is not desired.

6 - Planning Commission submission materials are due from the applicant and/or applicant's representative by this date. See Planning Commission Submission transmittal for requirements.

7 - Plans and unpaid fees that are not submitted by the required resubmittal deadline may not be accepted and application may be placed on the subsequent Initial Submittal schedule by the department.

8 - Signs may be withheld if the planner assigned the application, or his/her supervisor determines there are substantial remaining conditions of approval, or outstanding comments/approval from a review agency. APFO LOU must be signed by the applicant and returned to the County prior to this date for signs to be issued.

9 - Applications may be withheld from FCPC meeting if the planner assigned the application, or his/her supervisor determines there are substantial remaining conditions of approval, or outstanding comments/approval from a review agency.

*Dates highlighted in gray are to alert the applicant to a shift in the standard schedule due to a holiday.
