FREDERICK, Md. – County Executive Jessica Fitzwater invites the public to join her at one of six upcoming town hall meetings to help set priorities for the Fiscal Year 2026 budget. There will be one public hearing in December, followed by one town hall in each of the five County Council Districts throughout January. All meetings are open to the public.

“Our budget should reflect our community’s needs, priorities, and values. Your input helps us create a budget that invests in what matters most to residents,” said County Executive Fitzwater. “I look forward to hearing from you as we work to address the needs of our community and plan for Frederick County’s future.”
