I want to bring my experience and advocacy background to elevate priorities such as learning environments, special education services, educator diversity, student rights, and fair treatment and compensation for all educational professionals.

My experience lobbying local, state, and national government for fair and adequate resources for our county, as well as budgeting and bargaining for several organizations, would be an asset. Recruiting and retaining exceptional educators requires competitive compensation packages that reflect regional norms and honor the professionalism, dedication, and work-life balance that all educators deserve. It also fosters a stronger community when students, educators, and parents live, work, and thrive together through a strong school system.

As a parent of two young children in Frederick County, I understand the critical importance of transparency, communication, and authentic collaboration between schools and families. Our district must consistently engage community stakeholders, seek feedback, and use that input to guide decision-making. When students and community members see themselves represented in their curriculum and in district and school leadership, and are supported by educators who are valued and respected, their academic foundation becomes even stronger. I see this every day in my own children's educational experiences, and it has led to academic, social, and personal successes for them.

Spending nineteen years coaching football, indoor track, and outdoor track at the high school level, and flag football and soccer at the local youth level. Coaching has given

me a unique and valuable perspective that directly strengthens my qualifications to serve on the Board of Education. Coaching has placed me on the front lines of students' daily experiences, where I've supported their growth, well-being, and academic priorities while fostering teamwork, discipline, and resilience. I've collaborated closely with teachers, administrators, and families to ensure students succeed both on and off the field, giving me firsthand insight into the needs of our school communities. This experience has taught me how to build positive relationships, manage diverse groups, communicate effectively, and advocate for the resources students and educators need to thrive. Through coaching, I've seen how strong schools and supportive environments shape student outcomes—knowledge I am committed to bringing to the Board of Education.

Together, we can ensure that Frederick County students have equitable access to AP courses, STEM programs, and opportunities at the Career Technology Center.
