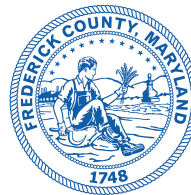

Frederick County offers a Subscription Club Program to all Frederick County residents that are transported by a Frederick County unit. Our Subscription Club Program helps the citizens of Frederick County by assisting with out-of-pocket expenses for medically necessary ambulance transports.

Your membership is effective for 1 calendar year and covers unlimited transports per enrolled member. In addition to the peace of mind for you, your membership also provides vital funding for your local EMS operations.

The cost of healthcare continues to rise. Your memberships can assist with Ambulance Transport fees which would otherwise be passed on to you. After an emergency the last thing you want to worry about is cost.

## Charges for an Ambulance Transport

Charges will vary depending on the severity of the call, ranging from a basic non-emergency incident to a life or death emergency.

Basic Emergency . . . . \$470.00  
Advanced Emergency 1 . . . . \$672.00  
Advanced Emergency 2 . . . . \$784.00

Transport "Loaded" mileage will also be charged at a rate of \$11.00 per mile. EMS providers will not obtain insurance information at the scene. We will make every effort to collect insurance information from the medical facility where you are transported.

## TYPES OF MEMBERSHIPS AND RATES

Senior Citizens (60+) . . . . . \$15.00/Yr

Individual . . . . . \$25.00/Yr  
(Including disabled)

Household . . . . . \$50.00/Yr

## During an emergency the last thing you want to worry about is a bill...

 **I have insurance, why should I subscribe?**

We encourage you to speak with your insurance carrier to discuss the coverage you may or may not have for ambulance transports. This way you can make an informed decision about this program.

 **How does it work?**

We will bill your insurance company for the cost of your care. We will then accept their payment and you are not responsible for any remaining balance.

 **What if I don't subscribe?**

We will bill your insurance for any services provided. After receiving payment you will be responsible for any outstanding portion.

 **Is this an insurance policy?**

No. The Subscription Club Program is available to supplement the insurance you already have. It is designed to assist with out-of-pocket expenses for emergency transports.

 **What if I don't have insurance?**

No one will ever be refused service due to lack of insurance or inability to pay. **If you have a medical emergency, call 911.**
