Frederick County Launches Feasibility Study on Future of Senior Centers

Public Invited to Participate and Provide Feedback

FREDERICK, Md. – The Frederick County Division of Aging and Independence is launching a feasibility study to ensure senior centers meet the evolving needs of older adults today and in the years to come. The study will look at where new senior centers might be needed and what programs should be offered. Members of the community are invited to attend sessions and complete surveys to share their input.

The Division of Aging and Independence is working with MGT, a consulting firm that specializes in working with local governments. MGT has visited all five senior centers in the county and is conducting a comprehensive assessment to help align services and facilities with the needs of Frederick's growing population.
